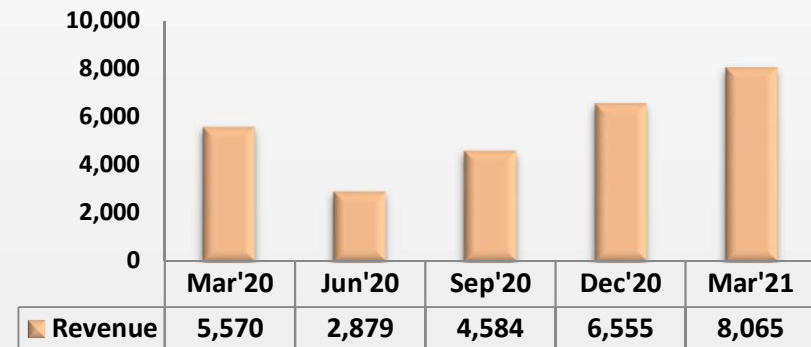

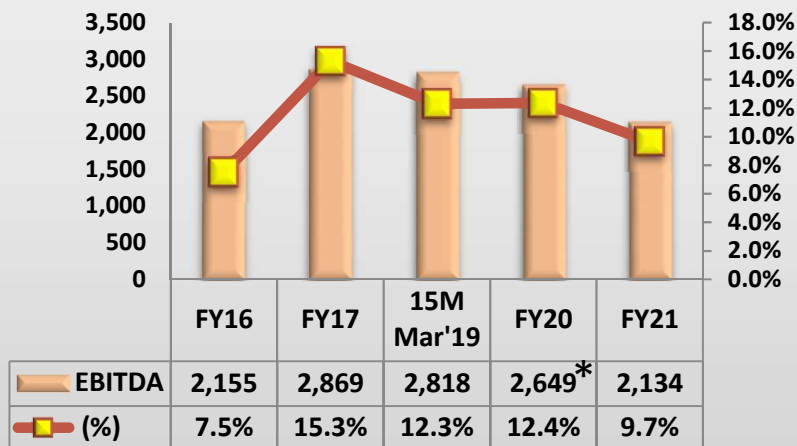
Yearly Revenue from operation



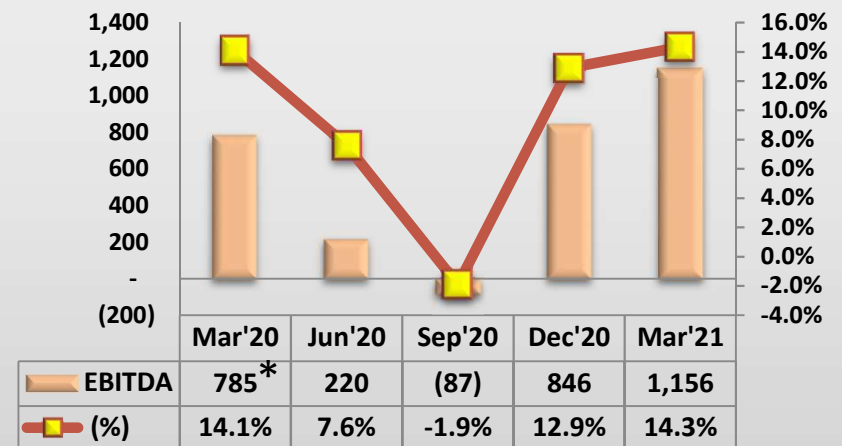
Quarterly Revenue from operation

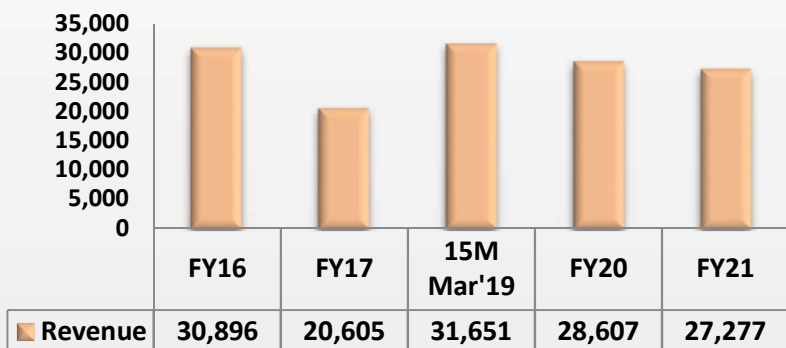

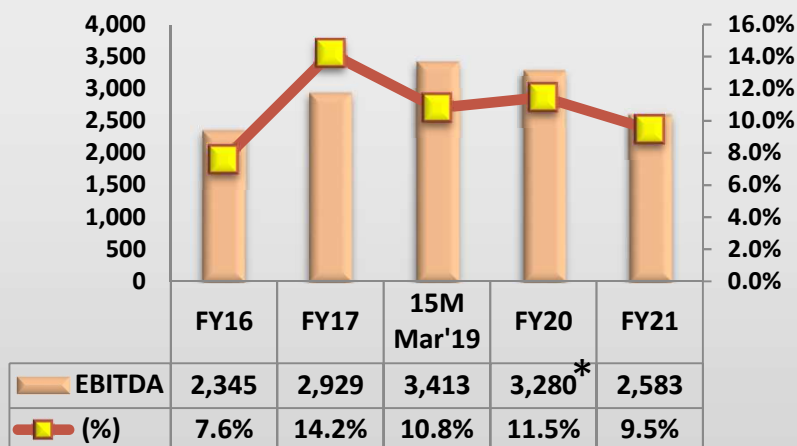
Yearly Revenue from operation



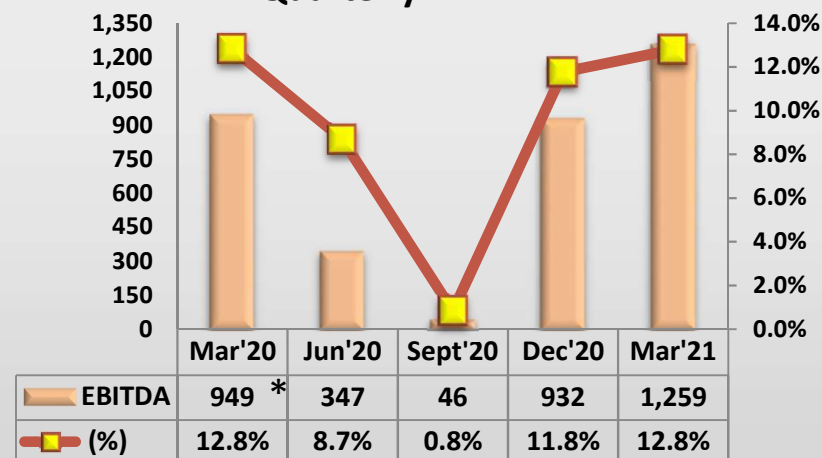
Quarterly Revenue from operation

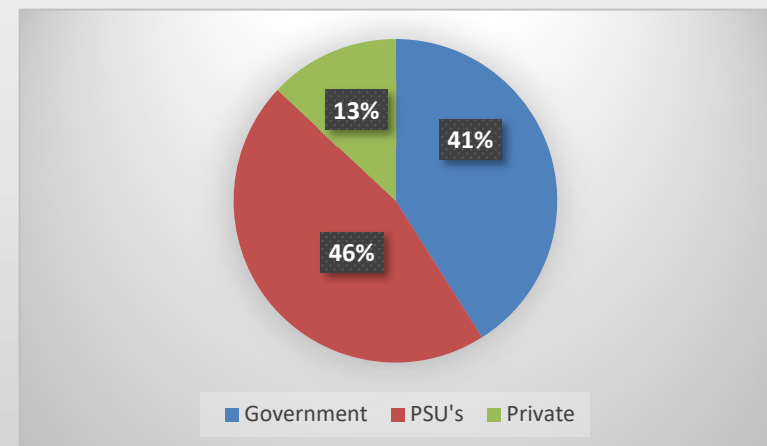
