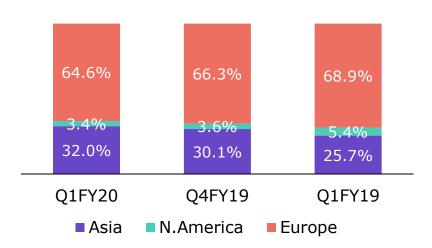

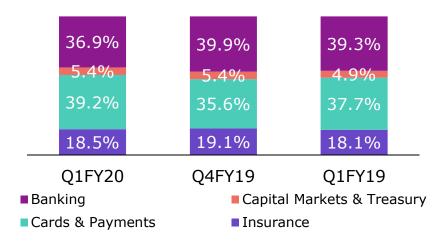

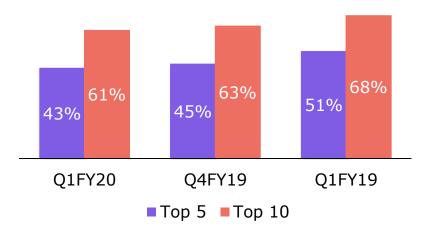
Revenue by Region



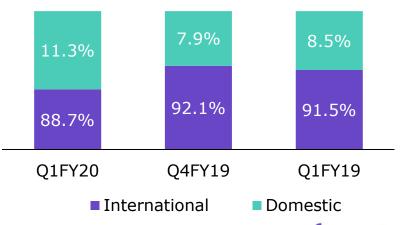
Revenue by Practice



Client Concentration (12m Rolling)



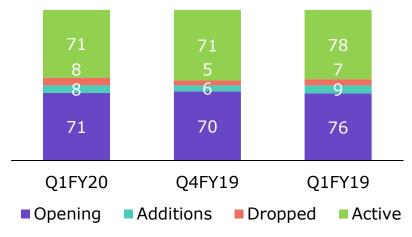
Revenue Distribution



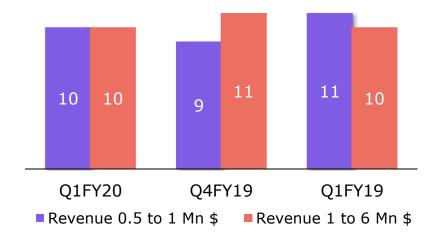

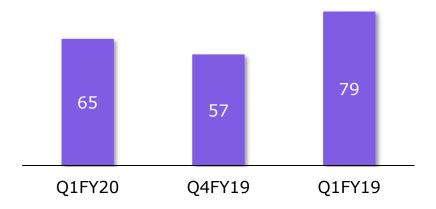

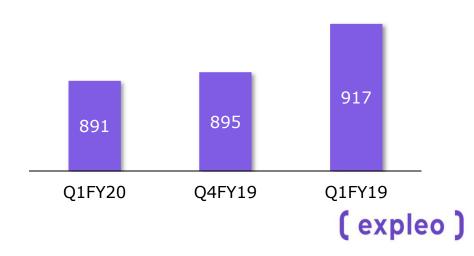
