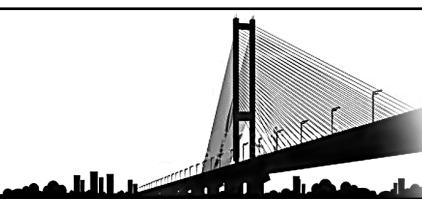

**Mumbai:** A fire broke out in a sixth floor room of the 11-storey Hinduja Hospital in Khar on Monday. No one was injured, an official said. The blaze started at 5:55pm and was doused 10 minutes later, the fire brigade official

said. "It was confined to wiring, electric installation and panel board. Four fire engines and other fire brigade vehicles were deployed to douse the fire. There is no report of injury to anyone," he said.

# Police arrest two in fake currency case

Police at BKC recently arrested two men accused of using fake currency to purchase goods worth Rs60,000. Ali Mehdi Sayyad (26) and Naushad Shah (36) both dropped out of hotel management studies.

According to sources, a tip-off alerted the police to the duo's use of counterfeit currency. The two utilised smaller denomination notes of Rs10 and Rs50 to escape scrutiny.

The arrests also led to the seizure of a printer, 600 sheets of bond paper, a scale, a cutter, and fake notes totalling Rs55,000.

Additionally, Rs80,000 in fake currency that had already been circulated was recovered. The police set a trap at Shah's flat in an SRA building in Bandra (East), resulting in the seizure of the fake notes and related paraphernalia on May 3.

# 'Mischievous': Court slams BJP ex-MLA over complaint

In an anti-corruption case, the Thane sessions court has questioned the character of the complainant, a former BJP legislator from Mira-Bhayander. The court has also acquitted the accused on the grounds of benefit of doubt.

Stating that the complainant, Narendra Mehta, was mischievous, the court maintained that he dared to depose falsely before the Bombay High Court as well as the Supreme Court.

As per the prosecution's case, in May 2012, a meeting of the standing committee was held in Thane, for selection of tender for Rajiv Aawas Yojana. The accused, Hitesh Solanki, had filed one tender for the same through his firm, Tandon Urban So-

lutions. It was the lowest bid. Mehta, however, claimed that Tandon Urban Solutions was not qualified as it did not possess the requisite eligibility for the tender. He requested the chairman and the members of the standing committee to adjourn the

subject of granting approval for the tender.

Mehta claimed that Solanki had approached him on May 24, 2012, to mention the tender. Solanki allegedly requested Mehta to recommend his name before the standing committee and offered a bribe of Rs4 lakh.

The accused in his reply stated that Mehta had misused his post and power and

had fabricated the documents and implicated Solanki.

The defence advocate for Solanki, Ranjit Sangle, said, "The complainant in the case is an accused in another corruption matter, which is already registered before the Anti-Corruption Bureau (ACB) Thane. In connection with the same, Mehta has filed affidavits before the Bombay High Court as well as the apex court and has deposed false [testimony] about his identity that he was a private person and not a government one when the corruption case was filed against him in 2002. The ACB Thane has challenged the same." Sangle explained the prime

reason as to why the alleged bribery case against Solanki was registered before the ACB headquarters. "The pendency of one crime against the Mehta in ACB Thane had led the complainant to file the present case with the headquarters."

The session's court while acquitting Solanki held, "The evidence on record shows the character of the complainant, which appears to be that of mischievous as the complainant dared to depose falsely not only before the Bombay High Court but also before the apex court."

In the recent update, the HC had asked the Thane police to conduct an impartial investigation and submit a progress report in a case registered in 2021 against Mehta.

# Builder penalised a second time for the same offence

The National Consumer Dispute Redressal Commission (NCDRC) has directed a Mira Road-based real estate developer to pay back the booking amount paid by one of its customers in 1998.

The commission, while upholding the state commission's order, directed the firm to pay Rs4,61,000 with 12% interest from 2003 onwards, along with Rs50,000 as an additional amount towards mental agony. As per the order copy, the developer was penalised in the same case by the criminal court in 1998. However, the amount was not specified before the commission.

The customer, Suresh Kumar, had approached Kalindi Enterprises to book a flat in its property named 'Vrindavan Avenue'. The cost of the property was Rs5,56,990, of which Kumar paid Rs31,000

as advance. It was agreed between the two that the remaining amount would be paid between August 1994 and September 1996.

The complainant said that the developer neglected to hand over the possession of the flat, and kept making fake assurances. Kumar finally de-

ecided to withdraw his interest from the property and asked the developer to return the invested money.

The developer issued two cheques to Kumar, which were dishonoured; however, the developer later paid via pay order, but failed to pay the remaining amount of

Rs4,16,000 to Kumar. He initially filed a criminal case and later approached consumer forums. The developer was penalised by the court.

Opposing the claim, the advocate for the developer said that the dual penalty for a similar case becomes a case of double jeopardy, but this argument was rejected by the NCDRC.

The NCDRC said, "Sometimes in certain contexts, some legal jurisdictions may sound to have an outwardly overlapping texture but that does not imply that they should be called mutually exclusive jurisdictions. The express language of sections of the Consumer Protection Act leaves no scope for ambiguity or misinterpretation in this regard. That is why the remedy, which provides for compensation under the Consumer Protection Act, is in addition to and not in derogation of other laws."

# Key stretch of Mum-B'luru Exp to open soon

The 72-km stretch between Chitradurga and Davangere in Karnataka, part of the six-lane Mumbai-Bengaluru Expressway, will be opened soon. In a post on social media platform X (previously Twitter) on Monday, Union Minister for Road Transport and Highways, Nitin Gadkari, said the stretch will save time and fuel, and give commuters an experience of eco-friendly travel.

"Traverse the vistas along the 6-lane Chitradurga-Davangere stretch, a lifeline linking Bangalore and Mumbai. This route isn't just about reaching destinations; it's a symphony of time-saving, fuel-efficient, and eco-friendly travel, weaving through Karnataka's natural splendour," Gadkari posted.

The minister announced the project in January 2023,

terming it as a 'lifeline' linking the country's commercial capital with the IT hub. The expressway will stretch across 699 kilometres and cost around Rs50,000 crore. It is expected to be opened to the public in 2028.

The National Highway Authority of India is constructing the highway, which will not only speed up connecti-

ty between two capital cities, but prove to be a catalyst of development in the entire stretch. The 72-km stretch is being constructed at a cost of Rs1,400 crore and would be

opened for the public soon. In order to decrease future maintenance costs, the project intends to employ sustainable techniques and materials, such as plastic in bituminous concrete and milling material in service roads.

The expressway will follow a well-planned route alignment, connecting major cities along the way. The proposed alignment includes Pune, Satara, Sangli, Belgavi, Dharwad, Hubli, Devanagere and Tumakuru. At the northern end, the expressway will commence from MSRDC's Pune Ring Road project, providing connectivity to rest of Maharashtra.

Major settlements along the alignment are Pune, Bhor, Phaltan, Khanapur, Satara, Tasgaon, Miraj, Kavathemahankal, Sangli, Belgavi, Bagalkot, Gadag, Koppal, Bellary, Davangere, Chitradurga, Tumkur and Bengaluru.
