

# Europe Covid death toll set to pass 300,000 as winter looms

LONDON: The COVID-19 death toll in Europe is set to pass 300,000, according to a Reuters tally on Tuesday, and authorities fear that despite hopes for a new vaccine, fatalities and infections will continue to rise as the region heads into winter.



With just 10% of the world's population, Europe accounts for almost a quarter of both the 50.7 million cases and 1.2 million deaths globally and even its well-equipped hospitals are feeling the strain.

After achieving a measure of control over the pandemic with broad lockdowns earlier this year, case numbers have surged since the summer and governments have ordered a second series of restrictions to limit social contacts.

In all, Europe has reported some 12.3 million cases and 295,000 deaths and over the past week, it has seen 280,000 cases a day, up 10% from the week earlier, representing just over half of all new infections reported globally.

Hopes have been raised by Pfizer Inc's announcement of a potentially effective new vaccine, but it is not expected to be generally available before 2021 and health systems will have to cope with the winter months unaided.

Britain, which has imposed a fresh lockdown in England, has

the highest death toll in Europe at around 49,000 and health experts have warned that with a current average of more than 20,000 cases daily, the country will exceed its "worst case" scenario of 80,000 deaths.

But France, Spain, Italy and Russia have also reported hundreds of deaths a day and together, the five countries account for almost three quarters of the total fatalities.

Already facing the prospect of a wave of job losses and business failures, governments across the region have been forced to order control measures including local curfews, closing non-essential shops and restricting movement.

France, the worst affected country in the EU, has registered more than 48,700 infections per day over the past week and

the Paris region health authority said last week that 92% of the region's ICU capacity was occupied.

Facing similar pressures, Belgian and Dutch hospitals have been forced to send some severely ill patients to Germany.

In Italy, which became a global symbol of the crisis when army trucks were used to transport the dead during the early months of the pandemic, daily average new cases are at a peak at more than 32,500. Deaths have been rising by more than 320 per day over the past three weeks.

While the new vaccine being developed by Pfizer and German partner BioNTech will take time to arrive, authorities are hoping that once winter is passed, it will stem further outbreaks next year. AGENCIES

# Armenia, Azerbaijan agree to end fight in Nagorno-Karabakh

YEREVAN (Armenia): Armenia and Azerbaijan announced an agreement early Tuesday to halt fighting over the Nagorno-Karabakh region of Azerbaijan under a pact signed with Russia that calls for deployment of nearly 2,000 Russian peacekeepers and territorial concessions.

Nagorno-Karabakh has been under the control of ethnic Armenian forces backed by Armenia since a 1994 truce ended a separatist war in which an estimated 30,000 people died. Sporadic clashes occurred since then, and full-scale fighting began on Sept. 27.

Several cease-fires had been called but were almost immediately violated. However, the agreement announced early Tuesday appeared more likely to take hold because Azerbaijan has made significant advances, including taking control of the strategically key city of Shushi on Sunday.

Armenian Prime Minister Nikol Pashinian said on Facebook that calling an end to the fight was extremely painful for me personally and for our people.

Soon after the announcement, thousands of people streamed to the main square in the Armenian capital Yerevan to protest the agreement, many shouting, "We won't give up our land! Some of them broke into the main government building, saying they were searching for Pashinian, who apparently had already departed."

The agreement calls for Armenian forces to turn over control of some areas it held outside the borders of Nagorno-Karabakh, including the eastern district of Agdam.

That area carries strong symbolic weight for Azerbaijan because its main city, also called Agdam, was thoroughly pillaged, and the only building remaining intact is the city's mosque.

Armenians will also turn over the Lachin region, which holds the main road leading from Nagorno-Karabakh to Armenia. AGENCIES

# Biden moves forward with his transition plans

## Trump campaign says presidential election far from over

WASHINGTON DC: As President-elect Joe Biden is gearing up for administering the country, the defiant Trump campaign has asserted that the 2020 US presidential election is far from over and indicated that it will explore all possible options to obtain "an accurate and honest vote count."

Outgoing President Donald Trump has declined to concede the closely-fought November 3 presidential race to Democrat Biden and is mounting legal fights in several key battleground states, but there has been no evidence of voter irregularities or widespread fraud in the election -- billed as one of the most divisive and bitter in recent American history.

The president's refusal to accept the results means the election disputes could drag for weeks as states certify their tallies or push to mid-December, when the 538-member Electoral College is set to vote.

President Trump has made repeated and baseless claims that the Democratic Party has tried to steal the election.

According to several US media projections, Biden has won at least 290 electoral votes, 20 more than the required 270 out of the 538 Electoral College votes. Trump has received 214 electoral votes.

Since media projected on Saturday that Biden had won the critical state of Pennsylvania, accumulating enough votes to claim the White House, the president-elect has forged ahead with his plans to take reins of the power.

On Monday, Biden formed a task force that will guide him on dealing with the coronavirus pandemic that has claimed over 236,000 lives in the country.

Biden cannot technically move to form a government using current government employees until his January inauguration, unless permis-



sion from Trump is granted to do so. Trump has not conceded to Biden or publicly accepted his loss. On Monday, White House Press Secretary made unsubstantiated claims of voter fraud.

This election is not over, far from it. We have only begun the process of obtaining an accurate, honest vote count. We are fighting for the rights of all Americans who want to have faith and confidence not only in this election but in the many elections to come, McEnany told reporters at a news conference with the Republican National Committee Chairwoman Ronna McDaniel.

Speaking in her capacity as a Trump campaign Advisor, McEnany attacked the Democratic Party, saying there is only one party in America that opposes voter ID, verifying signatures, citizenship, residency and eligibility.

There is only one party in America trying to keep observers out of the count room and that party my friends is the Democratic Party. You don't take these positions because you want an honest election, she said. You don't oppose an audit of the vote because you want

# Trump accuses FDA, Pfizer of withholding Covid vaccine announcement before polls

WASHINGTON DC: US President Donald Trump on Monday accused the Food and Drug Administration (FDA) and Pfizer of withholding the announcement on COVID-19 vaccine before elections to prevent him from getting a "vaccine win".

The US Food and Drug Administration "and the Democrats didn't want to have me get a Vaccine WIN, prior to the election, so instead it came out five days later As I've said all along!" Trump said in a tweet. Early in the day, pharma major Pfizer announced that its vaccine, as per preliminary estimates, has been found to

be 90 per cent effective in preventing COVID-19.

Pfizer said that the vaccine candidate was found to be more than 90 per cent effective in preventing COVID-19 in participants without evidence of prior SARS-CoV-2 infection in the first interim efficacy analysis. Analysis evaluated 94 confirmed cases of COVID-19 in trial participants, it said. Trump alleged, "If Joe Biden were President, you wouldn't have the Vaccine for another four years, nor would the @US\_FDA have ever approved it so quickly. The bureaucracy would have destroyed millions of lives!" AGENCIES

# Donald Trump fires Defence Secretary Mark Esper

WASHINGTON DC: US President Donald Trump has fired his Defence Secretary Mark Esper.



"I am pleased to announce that Christopher C Miller, the highly respected Director of the National Counterterrorism Center (unanimously confirmed by the Senate), will be Acting Secretary of Defense, effective immediately," Trump said in a tweet on Monday.

"Chris will do a GREAT job! Mark Esper has been terminated. I would like to thank him for his service, he said in his second tweet.

Trump's first firing of his Cabinet colleagues comes days after major media outlets declared that he has lost the November 3 elections to Democratic presidential candidate Joe Biden.

Trump's firing comes days after Esper in an interview told The Military Times that

he was not a "yes man" for the president.

"My frustration is I sit here and say, Hm, 18 Cabinet members. Who's pushed back more than anybody? Name another Cabinet secretary that's pushed back, he told The Military Times.

"Have you seen me on a stage saying, 'Under the exceptional leadership of blah-blah-blah, we have blah-blah-blah-blah?'" he said.

Travel to India to attend the 2+2 ministerial meeting was Esper's last foreign travel as defence secretary. AGENCIES

# UK school meals scheme restored after govt U-turn

NEW DELHI/LONDON: British Prime Minister Boris Johnson's government, which stopped free school meals during school holidays last month, has restored the meals scheme—though in a circuitous way—after opposition Labour supporters staged protests against the move.

Instead of directly releasing funds for the scheme, the Johnson government has increased allocations to local authorities or municipal councils to meet the expenses of the school meals.

It has raised the allocation by an hefty 107 million pounds for the period up to March 2021.

Another 220 million pound allocation has been pledged

for the period April to December 2021 under a plan called Holiday Activities and Food Programme.

The restoration of holiday meals for the poorer children comes after several top Tory MPs, including Indian origin Finance Minister or Chancellor Rishi Sunak, were barred from their local pubs and restaurants over children's holiday meals cuts.

Child rights campaigners, whose nationwide petition attracted 4.3 lakh signatures, said they would not rest until child poverty is abolished and the country is rid of the triple burden of malnutrition -- hidden hunger, underweight and overweight. MP0ST

# Jordan holds parliamentary polls amid virus surge

AMMAN: Jordanians began voting on Tuesday to elect a new parliament in the country that has long been a close Western ally in a volatile region and is now struggling to contain a coronavirus outbreak.

Voters will elect 130 members of the lower house of parliament, with 15 seats reserved for women, nine for Christians
