This is with reference to our earlier correspondence regarding non compliance of Regulation 17 (1) of the SEBI (LODR) Regulations, 2015 as amended.

We would like to mention that our company got covered in the list of top 1000 companies on account of market capitalization for the year ended 31.3.2020. No communication was received about the change of category on account of which we were required to do certain additional compliances in respect of board of directors and various committees.

On receiving the intimation from the exchanges in the month of October 2020 about the change of category and need for additional compliances we have been working on the same and have achieved the compliances as required for companies falling in top 1000 category by market capitalization.

In our earlier correspondence, we had requested for grant a time of three months for the purpose of regularizing the required compliances due to the reasons as mentioned in our request letter.

We wish to inform you that we have now for the quarter ended 31<sup>st</sup> December, 2020 complied with the applicable regulations and we have uploaded the Compliance Report on Corporate Governance on the respective portals of both exchanges on 2<sup>nd</sup> January, 2021.
