With reference to the above and further to our earlier intimations dated October 04, 2023 and February 01, 2024 and in compliance with Regulation 30 read with Schedule III of the Listing Regulations and pursuant to the Share Sale & Termination Agreement dated October 03, 2023 ("the Agreement") entered into amongst Nodwin Gaming International Pte Ltd. (Nodwin Singapore), a wholly-owned subsidiary of Nodwin Gaming Private Limited, a material subsidiary of the Company, Nazara Technologies FZ LLC (Nazara Dubai), a wholly owned subsidiary of the Company, Publishme Global FZ LLC (PublishMe), a subsidiary of Nazara Dubai and Mr. Ozgur Ozalp, founder shareholder of PublishMe, as referred to in our earlier above-referred intimations / communications, we hereby inform you that Nodwin Singapore has completed the acquisition of 100% stake of PublishMe by way of secondary purchase of 82.81% stake from Nazara Dubai for a consideration aggregating to USD 2 mn, paid in cash and the balance 17.19% stake of PublishMe from Mr. Ozgur Ozalp for an aggregate consideration of USD 1, paid in cash.

With completion of the aforesaid transaction, PublishMe ceased to be a subsidiary of Nazara Dubai and became a wholly owned subsidiary of Nodwin Singapore and a step-down subsidiary of both Nodwin and the Company. Further, Arrakis Tanitim Organizasyon Pazarlama San. Tic. Ltd. Sti., Turkey ("Arrakis"), a wholly owned subsidiary of PublishMe, also became a step-down subsidiary of Nodwin Singapore, Nodwin and the Company.
