





R&D EXPENDITURE % TO REVENUE FROM OPERATIONS




% OF REVENUE FROM OPERATIONS FROM R&D DEVELOPED PRODUCTS








REVENUE FROM OPERATION – Q1







REVENUE FROM OPERATION






GROSS MARGIN






