At the outset , I wish to thank the Company and it's Shareholders for giving me the opportunity to serve as an Independent Director of the Company and it has been a most enriching experience for me.

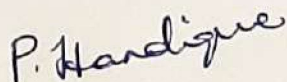
Since I will be pursuing an employment opportunity which will constrain my working as an Independent Director of the Company , please accept my resignation from the post of Independent Director.
