








9M FY 20-21 : Nine Monthly Performance - Standalone

















Quarterly Performance Track Record – Standalone







Segmental Break up



Domestic Vs Overseas




Total Orders Segmental Break up




9M FY 20-21 : Order Book Break up - Standalone




