The Allotment Committee of the Board of Directors of the Company at its Meeting held today, has approved an allotment of 16,450 equity shares of Rs.10/- each, being the exercise of 3,468 equity stock options under the Employee Stock Option Scheme, 2013 (ESOS 2013), 4,875 equity stock options under the Employee Stock Option Scheme, 2014 (ESOS 2014) and 8,107 equity stock options under the Employee Stock Option Scheme, 2022 (ESOS 2022).
