Scrutinizer's Report on postal ballot voting by way of remote voting by electronic means in respect of passing of the resolutions set-out in the notice dated 28th March, 2024 through Postal Ballot.

- 1. We, Mr. V Suresh, Senior Partner of M/s. V Suresh Associates, Practising Company Secretaries, have been appointed as a scrutinizer by the Board of Directors of the Company for the purpose of scrutinizing the Postal Ballot voting process in compliance with the Companies Act, 2013 and the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 in a fair and transparent manner on the resolutions contained in the postal ballot notice dated 19th March, 2024 ("Notice") issued in accordance with the Ministry of Corporate Affairs (MCA) vide Circular No. 14/2020 dated April 8, 2020, Circular No.17/2020 dated April 13, 2020 read with Circular No.22/2020 dated June 15, 2020, Circular No. 33/2020 dated September 28, 2020, Circular No. 39/2020 dated December 31, 2020, Circular No. 10/2021 dated June 23, 2021, Circular No 20/2021 dated December 8, 2021, Circular No 3/2022 dated May 5, 2022 and General Circular No. 10/2022 & 11/2022 dated December 28, 2022 and 09/2023 dated September 25, 2023 issued by Ministry of Corporate Affairs (MCA), Government of India (hereinafter referred to as "MCA Circulars") and SEBI vide its circulars dated May 12, 2020, January 15, 2021, May 13, 2022 and January 05, 2023 (collectively referred to as "SEBI Circulars").
- 2. The Management of the Company is responsible to ensure the compliance with the requirements of the Companies Act, 2013 and Rules made thereunder and the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 relating to Postal Ballot process through remote e- voting, on the resolutions contained in the Postal Ballot Notice pursuant to the provisions of Sections 108 & 110 of the Companies Act, 2013 and Rules thereunder. Our responsibility as a scrutinizer for e-voting and postal ballot process is restricted to presenting a Scrutinizer's report on the votes cast "in favour" or "against" the resolutions stated above, based on the reports generated from the e-voting system provided by Central Depository Services (India) Limited ("CDSL") the authorized agency engaged by the Company.



- 3. We, submit herewith our report on the results of e-voting together with postal ballot as under:-
 - 1. The Postal Ballot notices were sent through email on 03rd April,2024 to all the Shareholders, whose name(s) appeared on the Register of Members/list of beneficiaries as on Friday, 29th March, 2024.
 - 2. Postal Ballot has been conducted in compliance with the Companies Act, 2013 and SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.
 - 3. The Public Advertisement with respect to dispatch of notices and conducting of voting was published in an English Newspaper Business standard (in English) and vernacular newspaper Makkal Kural (in Tamil) having a wide circulation, in their respective editions dated 04th April, 2024.
 - 4. The e-voting period remained open from Friday, 05th April,2024 (9.A.M. IST) and ends on Saturday,04th May,2024 (5:00 P.M IST).
 - 5. The members of the Company as on the "cut-off" date i.e. Friday, 29th March, 2024 were entitled to vote on the resolutions in the Postal Ballot Notice.
 - 6. The Corporate members have provided the copy of the resolutions passed at the Board of Directors for authorization to exercise their votes.
 - 7. The votes cast were unblocked on Saturday, 04th May, 2024, at 5.00 P.M in the presence of 2 witnesses, who are not in the employment of the Company.

Thereafter, the details containing inter alia, list of Equity Share Holders, who voted "for", "against" each of the resolutions that were put to vote, were generated from the e-voting website of Central Depository Services (India) Limited ("CDSL") (i.e.) https://www.evotingindia.com/ based on such reports the results of the e-voting is generated.
