1. Appointment as Scrutinizer:

2021, 3/2022 dated May 5, 2022 and 11/2022 dated December 28, 2022 and 09/2023 dated 25th September, 2023 issued by the Ministry of Corporate Affairs (collectively referred to as "MCA Circulars"), Regulation 44 of the Securities and Exchange Board of India ("SEBI") (Listing Obligations and Disclosure Requirements) Regulations, 2015, ("SEBI LODR") and other applicable provisions, if any, of the SEBI LODR, for the time being in force and as amended from time-to-time and Secretarial Standard on General Meetings issued by the Institute of Company Secretaries of India ("SS-2").

2. Dispatch of Postal Ballots:

- 2.1 The Company had dispatched Postal Ballot Notice along with Explanatory Statement on 5th April, 2024 through electronic mode only to all those Members, whose e-mail addresses were registered with the Company or Registrar and Share Transfer Agent of the Company or with their respective Depository Participants and whose names appear in the Register of Members of the Company/ List of Beneficial Owners as maintained by the Depositories as on 30th March, 2024 ("Cut-off-date"). The Postal Ballot Notice was made available on the website of the Company, website of BSE Limited and also on the website of National Securities Depository Limited (hereinafter referred to as "NSDL"), , the authorized agency appointed for providing e-voting facility to enable the members to cast their votes electronically.
- 2.2 An advertisement was published in Financial Express (English) and Jansatta (Hindi), Delhi editions on 6th April, 2024 intimating members about having dispatched the ballot papers by electronic means.

I hereby submit my report as under:

a) Management of the Company is responsible to ensure compliance with requirements of the Companies Act,2013 and Rules relating to Postal Ballot process on the Resolution contained in the Postal Ballot Notice dated 30th March,2024.

- b) My responsibility as Scrutinizer for Postal Ballot process is limited to make a Scrutinizer's Report of the votes cast "in favour" or "against" the resolution contained in the said notice dated 30th March, 2024, based on the reports generated from the e-voting system provided by NSDL, the agency engaged by the Company to provide e-voting facilities for voting through electronic means.

- d) The shareholders holding shares/beneficial holders as on the "cut-off date" i.e. 30th March,2024 were entitled to vote on the proposed resolution as set out in the Notice of postal Ballot dated 30th March, 2024 of the Company.
- e) The votes were unblocked on 6th May,2024 by me in the presence of two witnesses namely Ms. Swarn Lata and Ms. Shashi Jain who are not in the employment of the Company.
- f) Thereafter, the details, containing, inter-alia, list of equity shareholders, who voted "in-favour" or "Against" were downloaded from the e-voting website of NSDL.
