infant boy from Tapi died in Surat's New Civil Hospital on Wednesday. Born on April 1, at the same hospital, she had health issues and was taken to the Neonatal Care centre.

Dr Alpesh Sanghvi, a paediatrician at the hospital said, "We carried out a Rapid Antigen Test (RAT)

then tested all the doctors and nursing staff in the ICU and nobody turned out positive. We later carried out test of her mother and found her to be Covid positive. We kept the baby on ventilator, when she reported breathing problems. We then carried out a RAT test

April 1, the baby had complications on the third day after the mother went home following a normal delivery. On April 3, the infant was shifted to Vyara civil hospital, where he was found positive for Covid 19, following which he was shifted to Surat Civil hospi-

strain. Hence, even children are contracting the disease this time. The earning members of a household get infected first and then pass the virus on to other members of the family," Ahmedabad-based paediatrician, Dr Nishchal Bhatt said.

Police: Two arrested, 18 Remdesivir vials seized

THE VALSAD police on Thursday nabbed two persons and seized 18 Remdesivir injections from their possession. The two had intended to sell the anti-viral injections at Rs 12,000 a vial instead of the actual cost of Rs 4,000, police sources said. One of the arrested persons works with a pharmaceutical company in Daman and exports such injections, they added.

The sources said that Valsad Special Operation Group personnel got a tip-off about a furniture showroom owner in Vapi GIDC possessing remdesivir injection and wanted to sell it to customers at Rs 12000 a vial.

Police sub-inspector Amirajsinh Rana went to the furniture showroom posing as a buyer. After seeing the injections, Rana paid Rs. 1.44 lakh for 12 vials to the showroom owner, identified as Varun Kundra.

After collecting the injec-

tions, Rana alerted a police team - waiting outside in plain clothes - and Kundra was nabbed. During interrogation, he confessed to having sourced the injections from one Manish Singh, a resident of Vapi who is employed with a firm at Dabhel village in Daman.

An SOG team picked up Manish Singh from his residence and seized six more such vials from his possession. After their Covid test reports turned out negative, Kundra and Manish Singh were arrested. Both of them were booked under IPC section 420, 114, Epidemic disease Act., section 3, Essential commodity Act., sections 3 and 7 and Drugs and Cosmetic Act., section 27.

Valsad SOG police inspector V B Barad said, "The firm that employs Manish Singh manufactures and exports Remdesivir injections but since April 12, the Centre had barred the export of such injections. Manish had given 12 injections to Varun Kundra to sell in the local market at higher rates."

Polls to APMC boards suspended

After court order, seized remdesivir vials given to hospital

Ahmedabad: Days after the Ahmedabad Police's Detection of Crime Branch (DCB) held an accused outside SVPI airport with 35 doses of Remdesivir injections that were sourced to be sold at higher rates in the black market, a court on Friday ordered the DCB to handover the doses to Civil Hospital in Ahmedabad.

The DCB on Tuesday arrested one person, Justin Pereira, outside SVPI airport with 35 doses of the injections, which the accused had brought from Delhi via flight.

D P Chudasama, assistant commissioner of police, DCB, said, "Given the current Covid situation, the DCB asked a state lawyer to represent the case and make demands in front of a court to hand over the injections the civil hospital in Asarwa of Ahmedabad. The court also observed that all such seized injections in future must be handed over to the civil hospital. The injections were handed over to the superintendent of the civil hospital."
