However, I have been informed by BSE Limited that my Demat Account has been frozen (Client Level Suspended for Debits), reason being XTGlobal Infotech Limited (Scrip Code 531225) for which I am the promoter was allegedly in violation of Regulation 17(1) of SEBI (LODR) Regulations. The Company in turn when contacted informed me that it is in compliance with the provisions of Regulation 17(1) of SEBI (LODR) Regulations.

The vacancy caused by the resignation of 6th Director has been filled by the Company within the timeline prescribed by Regulation 25(6) of the SEBI (LODR) Regulations and hence the violation relating to appointment of 6th Director on the Board does not arise. But unfortunately, BSE Limited has taken the extreme action of freezing of Promoters Demat Accounts without considering the facts and circumstances of the case. The Company has already sent in its email/letter to BSE (dated March 14, 2021) stating the facts and requesting BSE to rectify the penal actions imposed by it on the shares held by me. Request your good selves to kindly look into the matter on a priority and do the needful.

Also request you to kindly take this instant communication on records in compliance with the requirements of Chapter V of the SEBI (SAST) Regulations, 2011.




