The management of the Company is responsible to ensure the compliance with the requirements of the Companies Act. 2013 and Rules relating to voting through electronic means (remote e-voting) on the resolutions contained in the Postal Ballot Notice as sent to the members of the Company. My responsibility as a scrutinizer for the remote e-voting process is restricted to make a Scrutinizer's Report of the votes cast in "favor" or "against" the resolutions stated below, based on the reports generated from the electronic voting system provided by the service provider agency.
