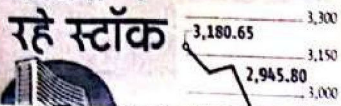

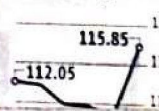

स्पाइसजेट अपनी पहली सी प्लेन सेवा गुजरात के अहमदाबाद में साबरमती नदी तट और केवाडिया में स्टैच्यू ऑफ यूनिटी के बीच शनिवार से शुरू करेगी। एक ओर का किराया 1,500 रुपये से शुरू होगा। विमानन कंपनी इस मार्ग पर रोजाना दो उड़ानों का संचालन करेगी जिसमें पट्टे पर लिए गए मालदीवियन एयरो के दिवन ओटर विमान का इस्तेमाल किया जाएगा। प्रधानमंत्री नरेंद्र मोदी संभवतः इसका उद्घाटन करेंगे और पहली उड़ान में यात्रा करेंगे।

लागत घटाने के लिए विदेशी पायलटों की बाहर

अनीश फडणीस मुंबई, 28 अक्टूबर

साल 2016 में जब सी एस सुबैया ने अलायंस एयर के मुख्य कार्याधिकारी का पदभार संभाला था तब उसके पास एटीआर विमान व पुराने सीआरजे जेट विमानों का बेड़ा था। विमानन कंपनी के पास एटीआर के पायलटों की संख्या सीमित थी और बेड़े का रोजाना इस्तेमाल 4.5 घंटे प्रति विमान था। सुबैया के पास पुराने जेट को जगह नए विमान लाने, एक तरह के विमानों को बेड़ा बनाना और नए मार्ग पर उड़ान शुरू करने का काम था।

तीन साल में ये कोशिशें आखिर कारगर रहीं क्योंकि एयर इंडिया की सहायक अलायंस एयर ने वित्त वर्ष 2020 में 65 करोड़ रुपये का परिचालन लाभ दर्ज किया। साल 1996 में शुरू होने के बाद यह पहला परिचालन लाभ है और यह संभव हुआ कम खर्च, विमानों के इस्तेमाल में बढ़ोतरी और बेहतर प्रतिफल से। शुद्ध स्तर पर कंपनी ने 201 करोड़ रुपये का नुकसान दर्ज किया, जिसकी वजह लेखा मानकों में बदलाव है, जो विमानन कंपनी को लीज की लागत को पूंजीकृत करना अनिवार्य बनाता है।

चूंकि कोविड ने हवाई यात्रा में व्यवधान पैदा किया है, लिहाजा सुबैया और उनकी टीम की चुनौतियां बढ़ गई हैं। अब विमानन कंपनी लागत नियंत्रण और स्थानीय पायलटों से विदेशी

पायलटों को बदलने पर ध्यान केंद्रित कर रही है। बेड़े के विस्तार की योजना को भी अभी रोक दिया गया है। कंपनी के पास अब 18 एटीआर-72 विमान हैं और सीआरजे जेट को तीन साल पहले हटा दिया गया।

सबसे बड़ी क्षेत्रीय विमानन कंपनी अलायंस एयर अभी रोजाना 77 उड़ानों का परिचालन करती है, जो पिछले साल 126 थी। इसमें उड़ान और गैर-उड़ान मार्ग शामिल हैं।

सुबैया ने कहा, हमें देखना होगा कि हम सबसे कम लागत बनाए रखें और यथासंभव ज्यादा से ज्यादा नकदी अर्जित करें। उन्होंने कहा, इसकी वजह यह है कि विमानन कंपनी इस क्षेत्र से संकट से निपटने पर विचार कर रही है।
