With Reference to the subject captioned above , we would like to state that SEBI vide circular no CIR/CFD/CMDI/27/2019 Dated 08.02.2019, Further circulars are issued by the SEBI in this regard ie circular no LIST/COMP/10/2019-20 and LIST/COMP/12/2019-20 DATED 9.5.2019 and 14.05.2019 respectively have clarified that the above mentioned compliance is not applicable to Listed entities falling under the Category of Regulation 15(2) of SEBI ( Listing Obligations and Disclosure Requirement ) 2015.

We hereby declare and confirm that Paid up Capital of the Company is Rs 5,35,00,000/- and Net Worth of the Company is well below 25 crores i.e Rs 9,64,39,082/- as on the last day of previous financial year i.e. 31.03.2020


As on 31.03.2019 the Paid up Capital of the Company is Rs 5,35,00,000/- and Net Worth of the Company is well below 25 crores i.e Rs 9,39,10,506/- enclosed herewith Net Worth Certificate for the same.
