Since BW No. 02 Electronic kit was damaged, the same was replaced with that of No. 03, presuming that it will not violate any reporting condition of CGWB as the water is not taken from from Bore Well No.03. After repairing the Electronic Kit, the same has been inserted in BW No. 03.
