In compliance with SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended from time to time, and SCILAL's Policy for Determination of Materiality of Events / Information, we hereby inform that:

The Company has received email(s) dated 22.05.2024 from BSE Limited and National Stock Exchange of India Limited levying fine of Rs. 1,68,740/- each (Rs. 1,43,000 each plus 18% GST) for non- compliance with Regulations 17(1), 18(1), 19 and 20 of SEBI (LODR) Regulations, 2015 w.r.t Composition of Board of Directors including failure to appoint woman director and constitution of various statutory committees.

The action does not have significant impact on financial, operation or other activities of the Company, quantifiable in monetary terms to the extent possible.

It may be noted that Shipping Corporation of India Land And Assets Limited ('SCILAL'), being a Public Sector Undertaking (PSU) is coordinating with Competent Authority for appointment of requisite number of Independent Directors on its Board. Once the requisite number of Independent Directors is appointed, the Company will constitute statutory committees mandated by Regulations 18(1), 19 and 20 of SEBI (LODR) Regulations, 2015.

The Company is in the process of submitting request letters to both of these Stock Exchanges for waiver of fine levied vide aforesaid notice(s).
