





1. Give us an idea about the After sales market.

Ans. Spares and service is an important segment for us. Currently, our share is low in this segment and we are taking efforts. Expansion of warehouses is going on. We expect to increase our share step by step.

2. What is your strategy for Solar business?

Ans. We have a 3 fold strategy: Integrator sale, to act as integrator and through dealers.
