## Summary of the proceedings of the 34th Annual General Meeting of the company.

The 34<sup>th</sup> Annual General Meeting of the members of Suryo Foods and Industries Limited (the company) was held on Monday, 25<sup>th</sup> September, 2023 at 11:30 A.M. at the registered office of the company situated at Dinalipi Bhawan, A-54/1 & A-55/1, Nayapalli, Baramunda, Bhbaneswar – 751 003, Odisha and concluded at 1:00 P.M.

The requisite quorum being present, Mr. Amarendra Dash, Chairman cum Managing Director of the company welcomed all members to the 34th Annual General Meeting of the company and called the meeting in order.

After delivering the Chairman's Speech, Ms. Manisha Satapathy, Company Secretary of the company was asked to take the proceedings forward.

Ms. Manisha Satapathy informed the members that the company had provided e-voting facility to all shareholders of the Company. - 3. To Re-appoint Mr. Ramakant Rath (DIN: 01277251) as an Independent Director of the Company for another term of five years.
- 4. To Re-appoint Mr. Bata Krishna Tripathy (DIN: 01752812), as an Independent Director of the Company for another term of five years.
- 5. To Re-appoint Mr. Rajendra Nath Mishra, (DIN: 01277767), as an Independent Director of the Company for another term of five years.
