I, K. K. Sanganeria, Practicing Company Secretary (FCS No. 2643/ C.P. No. 3880, Proprietor of M/s. K. K. SEBI/HO/CFD/CMD1/CIR/P/2020/79 & SEBI/HO/CFD/CMD2/CIR/P/2021/11 dated 12<sup>th</sup> May, 2020, 15<sup>th</sup> January, 2021 and all other relevant circulars issued from time to time further provided relaxation from dispatching of physical copies of notice of Extra Ordinary General Meeting (EGM) (including Attendance Slip and Proxy Form) has been sent on 16.02.2024 only through electronic mode to those Members/Shareholders whose e-mail IDs are registered with the Registrars/Depositories. The requirements of sending physical copy of the Notice of the EGM to the Members have been dispensed in compliance with above mentioned circulars of MCA and SEBI.

The Management of the Company is responsible to ensure the compliance with the requirements of the Companies Act, 2013 and Rules framed there under and SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and relating to voting through electronic means (i.e. by remote evoting) and voting by Ballot at the EGM for the resolutions contained in the Notice to the EGM of the Company. My responsibility as a scrutinizer for the voting process of voting through electronic means (i.e. by remote e-voting) is restricted to make a consolidated scrutinizer's report of the votes cast "In Favour" or "Against" the resolutions, based on the reports generated from the e-voting system provided by NSDL, the Agency authorized under the Rules and from Ballot Papers received at the venue of the EGM of the Company.

I submit my report as under:-

The Remote e-voting period remained open from Wednesday, 6th March, 2024 (9:00 a.m. IST) and ended on Friday, 8th March, 2024 (5:00 p.m. IST). The members of the Company as on the "cut off" date i.e. Saturday, 2nd March, 2024 were entitled to vote on the resolutions as set out in the notice of the EGM of the Company.

The votes cast on remote e- voting were unblocked at 12.53 p.m. on 11th March 2024, in the presence of two witnesses, who were not in employment of the Company and e-voting result/ list of equity shareholders who have voted "IN FAVOUR" and "AGAINST" were downloaded from the e-voting website of National Securities Depository Limited (NSDL) i.e. website www.evoting.nsdl.com.

After the time fixed for closing of the physical voting at the EGM by the Chairman, one ballot box kept for physical voting was locked in my presence. The locked ballot box was subsequently opened in my presence and two witnesses not in employment of the Company and it was found that 3 nos. of ballot papers was submitted physically at EGM. Further no ballot was also received from any shareholder through post. The consolidated results of voting i.e. remote e-voting and physical voting at the EGM are hereunder:-
