IDENTIFYING RURAL ECON-OMY and agriculture as the 'main focus areas' for selfreliance, Union minister Nitin Gadkari on Tuesday said Prime Minister Narendra Modi's 'aatmanirbhar'(self-reliant) vision will make the country prosperous and powerful.

Speaking at Symbiosis golden jubilee lecture series here on 'Aatmanirbhar Bharat', the BIP MP underlined the need to select a direction for making the country self-reliant.

"There is a need to formulate policies on how to implement 'aatmanirbharata' (self-



reliance) in every sector. It is not only the responsibility of governments but it is also the collective responsibility of various fields like education, health etc in society," said Gadkari.

The Union minister for road transport and highways also highlighted the need to form vision for every sector.


