Subject: Outcome of the meeting of the Board of Directors of K K Fincorp Limited (“Company”) in accordance with Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.

Pursuant to Reg. 30 of the SEBI (LODR) Regulations, 2015, we wish to inform that the Board at its meeting held today, has given in-principle approval for voluntarily delisting of Remi Sales and Engineering Limited (“Target Company”) alongwith other members of the Promoter Group of the Target Company under the Securities and Exchange Board of India (Delisting of Equity Shares) Regulations, 2009 as amended from time to time (“Delisting Regulations”).
