Sub: Intimation of Closure of Trading Window

As per our intimations dated August 11, 2023 ,August 12, 2023 and Corrigendum dated August 14, 2023 the Company has already informed to the Stock Exchanges regarding Approval of Resolution Plan for Srei Infrastructure Finance Limited and Srei Equipment Finance Limited (the "Corporate Debtors"/ "Companies") by Hon'ble National Company Law Tribunal, Kolkata ("NCLT") pursuant to its order dated August 11, 2023, under Section 31 of the Insolvency and Bankruptcy Code, 2016 (the "IBC ").

Further, in order to avoid the market complications, BSE Limited vide its Notice No. 20230814-10 and National Stock Exchange of India vide its circular No.1041/2023 have suspended the trading in the securities i.e. of Srei Infrastructure Finance Limited and Srei Equipment Finance Limited, w.e.f. August 14, 2023.

Please be informed that the trading window, in accordance with the Company's Code of Conduct for Prohibition of Insider Trading (Srei Insider Code), framed pursuant to the Securities and Exchange Board of India (Prohibition of Insider Trading) Regulations, 2015, shall be closed for dealing in the securities of the Company for all the Insiders (including Directors and Designated Persons as per Srei Insider Code and their immediate relatives) of the Company and its material subsidiary from Sunday, 1st October, 2023.

The trading window will open after 48 (forty eight) Hours from announcement to the Stock Exchanges of the Financial Results of the Company for the Quarter and Half-Year Ended on 30th September, 2023. The date of re-opening of trading window will be notified in due course.

Accordingly, all the Insiders (including Directors and Designated Persons as per Srei Insider Code and their immediate relatives) of the Company and its material subsidiary are being intimated not to enter into any transaction involving the securities of the Company during the aforesaid period of closure of Trading Window.
