2. Under sub section (4) of Section 9 of the Code, the Adjudicating Authority has to forward the name of Resolution Professional proposed under clause (b) of sub section (3) to the Insolvency and Bankruptcy Board of India for its confirmation and shall make such appointment after the confirmation of IBBI has already sent letter No. IBBI/NCLT/2017-18/17/160/200, Board. dated 03.11.2017 to the effect that there is a database already prepared in respect of all the registered resolution professional, which discloses whether any disciplinary proceeding is pending against an Insolvency Professional. So, in case, there is nothing against the person proposed, the Adjudicating Authority may appoint such person instead of seeking the confirmation from the IBBI. The Law Research Associate attached to this Tribunal has taken the print out from the database of Insolvency and Bankruptcy of India and the present status in respect of Mr. Kuldip Kumar Bassi, IP is that there is nothing adverse on record.

6. In view of the foregoing facts, we allow the instant application and appoint Mr. Kuldip Kumar Bassi, having registration No. IBBI/IPA-001/IP-P00280/2017-18/10524, Address: #410, Level IV, Centrum Plaza Golf Course Road, Sector 53, Gurgaon, Haryana-122011 as the Resolution Professional by replacing Mr. Ravinder Agarwal, the Interim Resolution Professional for continuing with the insolvency resolution process in respect of the corporate debtor. It is directed that:
