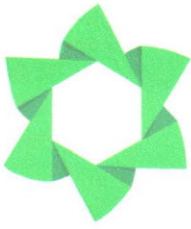

(IST) through video conferencing ("VC")/Other Audio Visual Means ("OAVM") in compliance with and as per the circulars issued by the Ministry of Corporate Affairs and the Securities and Exchange Board of India.

2. Brief details of items deliberated and results thereof

2.1 Brief summary of the proceedings and the details of items deliberated

The requisite quorum being present, Mr. Lakshmi Niwas Bangur, Chairman of the Company welcomed all the Members and Directors & KMP's present at the AGM. He also informed that Representative of M/s B. 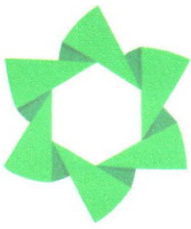

2. Declaration of Dividend on Equity Shares of the Company for the financial year ended March 31, 2023.
3. Re-appointment of Mr. Lakshmi Niwas Bangur (DIN: 00012617), as a Director of the Company liable to retire by rotation.

4. To Approve Material Related Party Transactions.
5. Continuation of Directorship of Mr. Lakshmi Niwas Bangur (DIN: 00012617) as a Non-Executive Director of the Company

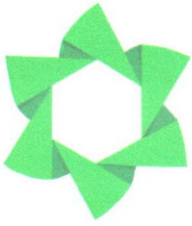
