As per the authorization issued by the Joint Commissioner (ST)(Int.), Coimbatore, for Surprise Inspection in the form of INS-01 serial No.171/2023-24 dated 09.08.2023 as in the reference cited, an inspection was conducted at your Principal Place of Business at No.99, Kovai Medical Center and Hospital Ltd, Avanashi Road, Coimbatore-641014.

During the course of Surprise Inspection, your Day Book, Ledgers, Bank Statements, Trading, Profit and Loss Statements, Balance Sheet, IT Statement, GST returns in form GSTR-1, 2A, 3B, and other connected records for the year from 2017 -2018 to July -2023 for further verification.

On verification of the above mentioned records for the year 2018-19 following defects were noticed.

#### Defect No 1

Non Collection of Taxes for Food items supplied to attenders of the Inpatients:-
