Independent Auditors' Report

To the Board of Directors of Karma Energy Limited

Report on the audit of the Annual financial results

Opinion

We have audited the accompanying annual financial results of Karma Energy Limited (hereinafter referred to as "the Company") for the quarter and year ended March 31, 2024 attached herewith, being submitted by the Company pursuant to the requirement of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended ('Listing Regulations').
