Summary of proceedings of the 75th Annual General Meeting of the Company

The 75th Annual General Meeting (the "AGM") of the Members of Jainex Aamcol Limited (the "Company") was held on Saturday, 30th September, 2023 at 12.00 p.m. at the Registered Office of the Company at L-3, MIDC Industrial Area P.O. Chikalhana Aurangabad - 431006, Maharashtra, India. The Meeting commenced at 12:00 p.m.

Mr. Kufna Bafna, Wholetime Director and CFO of the Company, chaired the proceedings of the Meeting.

The Chairman welcomed all his colleagues on Board and Shareholders of the Company. The requisite quorum being present, the Chairman called the meeting to order. He informed the Members that:

- Mr. M. Z. Kothari, Managing Director, Mrs. Bharati Bafna, Director and Ms. Sonam Dubey, Company Secretary and Compliance Officer were present at the Meeting.
- Mr. Hitesh Popat, Independent Director and Chairman of Audit Committee, Nomination and Remuneration Committee and Stakeholders Relationship Committee were present at the meeting.
- Mr. Sachindra Misra and Mr. Murli Dhar Motwani, Independent Director and Member of the Nomination and Remuneration Committee and Stakeholders Relationship Committee respectively were present at the Meeting.
- Mr. Sunil Sampatraj Parakh, Independent Director and member of Audit Committee, Nomination and Remuneration Committee and Mr. Rahul Dugar, Director could not attend the Meeting in view of their personal exigencies.
- The representative of Secretarial Auditor and the Statutory Auditors were present at the Meeting.
- M/s. Jainex Foods Private Limited had appointed Authorised Representative to attend the Meeting on their behalf.
- Bhagat Singh Dugar had appointed proxy to attend the meeting.



The Register of Proxies and the Statutory Registers as required to be kept open for inspection under the Companies Act, 2013 were available for inspection by the Members at the entrance of the hall.

- The copies of the AGM Notice together with the Annual Report for the Financial Year ended March 31, 2023 had been sent to all the Members and with the permission of the Members took the Notice as read.
- The Auditor's Report on the Financial Statements of the Company for the year ended March 31, 2023 has been sent to Members and accordingly with the permission of the Members took the Auditor's Report as read.

The Chairman then, gave an overview of the financial performance of the Company for the Financial Year ended March 31, 2023 and its future outlook.

The Chairman further informed the Members that in compliance with the provisions of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 and Regulation 44 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Company had provided to its Members, facility to cast their votes by electronic means through remote e-voting platform of National Depository Services (India) Limited (NSDL) in respect of all resolutions as set out in the Notice convening the 75th AGM. The remote e-voting commenced on **Wednesday, September 27, 2023 at 09:00 A.M. (IST)** and ended on **Friday, September 29, 2023 at 05:00 P.M. (IST)**. Members who were present at the AGM and had not cast their vote electronically were provided an opportunity to cast their votes through ballot paper at the end of the Meeting. It was further informed that there would be no voting by show of hands.

The following items of business as set out in the Notice convening the 75th Annual General Meeting were commended for Members consideration and approval:

ORDINARY BUSINESS:

1. Adoption of Audited Financial Statement of the Company for the Financial Year ended 31st March, 2023 together with the Reports of the Board of Directors and the Auditors thereon. **(Ordinary Resolution)**
2. Appointment of Mr. Rahul Dugar (DIN: 00013704) as a Director retiring by rotation. **(Ordinary Resolution)**
3. To consider appointment of M/s. R K Jagetiya & Co., Chartered Accountants, (Firm Registration Number: 146264W) as Statutory Auditors of the Company. **(Ordinary Resolution)**

SPECIAL BUSINESS:

4. To approve related party transaction for the financial year 2023-24. **(Ordinary Resolution)**



5. To approve related party transaction in respect to holding of office or place of profit in the Company by Mr. Mudit Bafna. **(Ordinary Resolution)**
6. To approve request received from Mrs. Ketaki Mazumdar, a person belonging to the Promoter Group of the Company reclassifying her shares, along with the shares belonging to her late husband, Mr. Ronojoy Mazumdar, and late brother-in-law, Mr. Sujoy Mazumdar from 'Promoter Group' to 'Public Category'. **(Ordinary Resolution)**

The Chairman then invited the members to ask questions and seek clarifications on the Agenda items. Thereafter, he gave reply to the queries and enquiries raised by the Members.

The Chairman further informed the Members that the Board of Directors had appointed Ms. Sonal Shah, Proprietor of Sonal Kothari & Associates, Practising Company Secretary (Membership No.: 24216, COP No.: 8769) as the Scrutinizer to scrutinize the Remote e-voting and ballot voting process in a fair and transparent manner and submit a Consolidated Report.

The Chairman thereafter, ordered a poll to be taken at the Meeting on all resolutions set out in the Notice convening the 75th AGM and requested representative of Ms. Sonal Shah, Scrutinizer, for an orderly conduct of the voting.

The Chairman further informed the Members that voting results along with the Consolidated Scrutinizer's Report shall be placed on the website of NSDL engaged for providing e-voting and will be communicated to the Stock Exchanges, where the shares of the Company are listed within 2 working days of the conclusion of AGM.

The Meeting concluded at 12:30 p.m. after the Members present at the Meeting casted their votes and the Scrutinizer sealed the poll box and took the custody of the same.


The Chairman thanked the Members for attending and participating in the Meeting.
