**Sub: Intimation under Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015**

This is to inform you that the Bank has received a communication on May 22, 2024, from Reserve Bank of India (RBI) stating that RBI had imposed a monetary penalty of Rs. 100/- on the Bank for discrepancies observed during processing of Soiled Note Remittances.

This penalty has been imposed in accordance with Master Direction DCM (CC) No.G-3/03.44.01/2023-24 dated April 03, 2023 on "Scheme of Penalties for bank branches and Currency Chests for deficiency in rendering customer service to the members of public".
