
Sub : Corporate Announcement on proposed funding plan of BPCL

At the Annual General Meeting of Bharat Petroleum Corporation Limited (BPCL) held on 11th September 2018, Shareholders of the Company approved 'Private Placement of Non-Convertible Bonds / Debentures and / or Other Debt Securities'.
