IBBI/IPA-001/IP-P-01697/2019-2020/12588) as Liquidator **as per section 33** of the Insolvency and Bankruptcy Code, 2016 ("**Code**") in matter of M/s Talwalkars Better Value Fitness Limited ("**Corporate Debtor/Company/ TBVFL**"), having its CIN: L92411MH2003PLC140134.

घर से निकला था। बाहर जाने के बाद वह अपने दोस्तों के साथ खाने-पीने चला गया। जहां पीने के दौरान उनके बीच झगड़ा हो गया। जिसके बाद उसके उक्त दोस्तों ने उसे मारकर उसे धरहरा पुल स्थित गुम्टी के पास सड़क किनारे फेंक दिया। सोमवार की सुबह मोहल्ले के ही एक युवक दम्रा उसके परिजनों को इसकी सूचना दी गई। सूचना पाकर परिजन घटनास्थल पर पहुंचे और उसे आनन-फानन में इलाज के लिए आरा सदन अस्पताल ले आए। जहां चिकित्सक ने देख उक्त मृत घोषित कर दिया। बताया जाता है कि मृतक अपने पांच भाई व तीन बहन में दूसरे स्थान पर था।

जिसको लेकर उसके दादा ने इसकी शिकायत उसके पिता से की थी। जिसके बाद धैरे उसे डॉट-फ्टकर लगाई थी तो वह कहने लगा कि मैं इस घर में नहीं रहूंगा। इसके बाद वह पिछले सोमवार की दोपहर करीब दो बजे घर से निकल गया और वह घर वापस नहीं लौटा। शनिवार को मोहल्ले के ही एक युवक ने ना कहा कि विन्ध्याचल वहां बेहोश पड़ा है तो उन्होंने कहा कि जाने दो नशा उतरने के बाद बस वापस चला आएगा। लेकिन वह घर वापस नहीं आया। रविवार दर रात मोहल्ले के युवक ने कहा कि नहर में डूब गया है। लेकिन रात काफी हो जाने के कारण परिजन नहीं आए। सोमवार की सुबह परिजन बाईपास रोड स्थित तपेश्वर इंद्र महिला कॉलेज के समीप नहर के पास पहुंचते तो उन्होंने देखा कि उसका शव नहर में पड़ा है। जिसके बाद परिजन ने उसके शव को पानी से बाहर निकाला। इसके पश्चात उन्होंने इसकी सूचना स्थानीय थाना को दी। वहीं दूसरी ओर मृतक की मां नीतू देवी ने नशीले पदार्थ का सेवन करने के कारण एव शौच करने के बाद पानी छूने के क्रम में नहर में गिर जाने से मौत होने की बात कही है।

## बैंक लूटकांड मामले में एक अपराधी गिरफ्तार

आनेयास्य का भय दिखाकर लूटपाट करने का प्रयास के आरोप में अंकित किया गया। उन्होंने बताया कि पुलिस अधीक्षक के द्वारा इस मामले में फरार चल रहे अपराध कर्मों की गिरफ्तारी हेतु मेरे नेतृत्व में परिक्षयमान पुलिस उपाधीक्षक मोहम्मद आदिल बिलाल नासरीगंज अंचल एवं काराकाट थानाध्यक्ष आदित्य कुमार को निर्देशित किए। तत्पश्चात सूचना संकलन किया गया तो पता चला कि इस कांड के अपराधियों की अभियुक्त संतोष कुमार मेहता पिता उषेंद्र मेहता साकिम अपनी थाना कसमा जिला औरंगाबाद अपने गांव आए हुए हैं।

Emails seeking comment sent to Dunzo and Reliance Retail did not elicit any response till press time Monday. In April, ET had reported that while Reliance Retail and Google had subscribed to the convertible notes, Dunzo’s ability to raise capital from other existing and new investors would depend on how the company’s business stabilises and it meets certain metrics after it changed its business model.

Dunzo was said to be on an annualised revenue run-rate of about \$300 million, till April, but this seems to have reduced significantly. It has capital to run operations for around 8-10 months, but is looking

to cut costs relentlessly to increase its cash runway. The company had scaled down the Dunzo Daily grocery quick-delivery services and laid off around 300 employees.

**MORE CHANGES IN BIZ**

Dunzo, which is also backed by venture capital funds like Blume Ventures and Lightbox, has been trimming its operations over the past few months as the hype over quick commerce has settled down. It had shut down half its dark stores before the April financing. People in the know said this has gone up to about 70% now. “You will never see a dark store in Indiranagar (a high-order-density location in Bengaluru) getting shut, but overall they have reduced their own dark stores by 70% now as the focus is to hit operations profitably,” one of the people said. The focus has also shifted to the business-to-business unit, Dunzo Merchant Services (DMS). Reliance Retail’s JioMart e-commerce arm is the largest contributor to DMS, accounting for more than 40% of the business.

“CEO (Biswas) has mentioned it internally as well that focus will be on B2B as that will not require the kind of capital needed to sustain Dunzo Daily—where its rivals are still expanding albeit at a much slower space than before,” another person said. According to him, Dunzo still is the leader in the pick-up-and-drop services, but is not among the top two in quick commerce or adjacent businesses. Its rivals in quick commerce include Swiggy Instamart, Zomato’s Blinkit, BigBasket’s BB Now and Mumbai-based upstart Zepto.

DMS does more than 30,000 orders a day, mostly last-mile delivery services, in seven cities. Dunzo had plans to expand DMS’ operations to 15 cities but has now cancelled those. DMS brings in roughly 35% of Dunzo’s revenues. It serves over 25,000 merchants and about 65-70% of them are in the food space, including McDonald’s, Licious and Theobroma.

The core team at DMS is about 20 people under cofounder Dalvir Suri and vice president of sales C Sumit Anand. Once clearly separated from the rest of Dunzo’s operations, the DMS team is increasingly co-ordinating with product and analytics teams in the B2C side, people in the know told ET.

Dunzo has platforms for medicines, grocery, pet supply, meat and others. It charges a commission from merchants and a delivery fee from the platforms’ users.

“China is slowing down and that is diverting a lot of interest and fund flows into our markets,” Choksey said.

Investors should remain watchful, however, given the sharp rally in Indian equities, said Choksey. “Stick with quality investment ideas,” he said.

Foreign portfolio investors (FPIs) were net buyers to the tune of Rs 73 crore in the cash segment on Monday, showed provisional stock exchange data. The flows on Monday are modest compared with the daily trend in recent weeks. Since the lows of March 2023, FPIs have been net buyers of local stock worth more than Rs 78,000 crore. Domestic institutions were also buyers in the cash segment worth Rs 64.34 crore, data showed.

Several Asian equity gauges declined after China, the world’s second largest economy, saw its second quarter gross domestic product (GDP) expand 6.3% against estimates of 7.3% growth. Japanese markets were closed for Marine Day while trading in Hong Kong was also closed due to a warning issued for Typhoon Talim. European shares retreated, with the pan-European Stoxx 600 down 0.63% after logging 2.4% last week, its best week since March.

In the US, the tech-heavy Nasdaq led Wall Street higher on Monday supported by megacap growth stocks including Apple and Tesla, ahead of quarterly results from industry heavyweights through the week.

At the time of going to press, the Nasdaq Composite was up 0.64%, the Dow Jones Industrial Average was up 0.25% and the S&P 500 was up 0.31%.

“India is the next big story and a big beneficiary from the slowing growth in China,” said UR Bhat, co-founder and director, Alphaniti Fintech.

“Cricket alone has three big events — Asia Cup, Australia’s tour of India and the World Cup. Over and above (this), new general entertainment shows and fresh seasons of reality shows are lined up in the second half of this year,” said Vinit Karnik, head (sports, e-sports and entertainment) at the WPP-backed GroupM South Asia. “All of this in the festive season is very attractive for advertisers to reach out to their target consumers. The (second half) of the calendar year has huge potential and is expected to see significant growth in terms of adspends,” said Karnik.

Since India is hosting the World Cup on its own for the first time, the event is drawing interest even from non-traditional advertisers. Milind Pingle, chief executive of Allana Consumer Products that sells premium ice-cream brand London Dairy, said, “The third quarter is pertinent to drive our brand’s agenda, considering the festivals. This year, the Cricket World Cup makes it even more exciting.”

**‘SECOND’ SUMMER**  
Companies making cooling products such as soft drinks, ice-cream and refrigerators are banking on the second half to make up for the double-digit rain-induced decline in sales, especially in the crucial June quarter.

Sundeep Bajoria, vice-president at beverages maker Coca-Cola, said, “Connecting our brand with consumers beyond summer continues to be our focus. It’s important for beverages to be integrated into occasions.” Earlier this month, he said the second half of the year would see a lot more advertising spend and consumer connect since the summer had been challenging.

Dabur, too, recently said it expects higher advertising intensity forecast in the year’s second half since input costs such as crude and palm oil had declined in the past three months. Kamal Nandi, executive vice-president at consumer durables and appliances maker

Godrej Appliances, said, “Ad and promotion spending on appliances like refrigerators is going to be big in the festive season, especially with the premium segment seeing high traction.” Nandi said high-end television brands would see incrementally higher spends because of the upcoming cricket season.

**GAMING SPOILER**  
However, the 28% goods and services tax (GST) levied last week on online gaming companies — which usually spend extensively on live events — would impact their ad purse, said a senior executive at a gaming company. “Unless there is a rollback of the GST, we will have to miss ad spending in such an attractive season, in all likelihood,” he said, requesting not to be identified.

**NCLT Grants Punj Lloyd Liquidator Extension till July 23 for Dissolution**

New Delhi: The National Company Law Tribunal on Monday allowed the liquidator in the Punj Lloyd case time till July 23 for the liquidation of the company.

The liquidator can file a fresh application after July 23 for seeking more time, the tribunal said.

The counsel appearing for the liquidator informed the tribunal that if the company could not be sold as a going concern due to differences in price discovery with



the expectations of the shareholders' consultative committee, the liquidator would attempt to sell Punj Lloyd in a piecemeal manner. Punj Lloyd had issued an advertisement for an e-auction of the company as a going concern on Ju-

ly 10 at a reserve price of ₹1,061 crore, after approval from the shareholders consultative committee. However, the company failed to attract any bidders.

ICICI Bank had approached the NCLT in 2018 to initiate insolvency proceedings against the company after it defaulted on a ₹854 crore loan.

The NCLT ordered liquidation of Punj Lloyd on May 27, 2022, after lenders rejected a revival plan submitted by a consortium of Prudent Asset Reconstruction Company and Payard Investments.

**India Needs Insurance Pool to Cover Natural Disasters: SBI Research**

New Delhi: India should create a disaster pool with public-private partnerships to ensure losses against natural disasters, said a note released by SBI Research on Monday. It said that as the number of natural disasters is increasing, the country needs an insurance model to protect against disasters which could offer benefits over government loans and grants during a crisis.

"Apart from the typical issues of planning up of urban infrastructure, the crucial issue of protection gap (uninsured losses) is almost neglected in a country like India," the note said, highlighting that economic losses from the floods in northern India and cyclone in Gujarat would have totalled ₹10,000-15,000 crore.

The protection gap in the case of India is 92%, much higher

than the global average of 54%, it said.

"India is a hugely under-insured country, compared to global peers. The insurance sector and governments need to actively engage and discuss how best to address the potential contingent liabilities," said SBI Research.

Citing the example of the 2020 floods, the researchers said the total economic loss amounted to ₹2,500 crore and that the premium to cover such losses would have been ₹13,000-15,000 crore.

"We believe the regulator/government should come out with some standardised products for various sectors so that the protection gap in each segment can be reduced significantly," said the note.

There is a need to offer higher protection for workers, especially in the MSME (micro-small and medium enterprises) sector, it said.

**SpiceJet Questions Maintainability of Petition Filed by Aircraft Lessors**

New Delhi: SpiceJet Monday argued against the maintainability of one of the two petitions from aircraft lessor Aircastle (Ireland) Limited and another one filed by Wilmington Trust SP Services (Dublin) Ltd in the National Company Law Tribunal (NCLT).

Aircastle (Ireland) told the NCLT Monday that it was within its right to file multiple petitions against defaults by SpiceJet on multiple contracts.

The counsel appearing for Aircastle (Ireland) in one of the later petitions filed by the company stated that as these were different aircraft and different invoices, separate petitions were filed by

the aircraft lessor.

The counsel stated that there was enough precedence from earlier judgements showing that multiple petitions could be filed by the same company against the corporate debtor.

SpiceJet, in its reply to the application, had stated that the same company cannot have multiple cause of action.

The bench asked the counsel appearing for Aircastle (Ireland) to place the legal precedent on record and listed the matter for August 17.

SpiceJet has also argued against the maintainability of the earlier petition filed by Aircastle (Ireland). The bench granted 10 days to SpiceJet to file a rejoinder. The matter is listed for arguments on August 8.

Dispute on control of JV

Govt asks companies to close negotiations



New Delhi: Russia's TMH and India's Rail Vikas Nigam Limited (RVNL) have been asked to iron out their differences that threaten to disturb the plan for roll out of new variant Vande Bharat trains. According to a top government official aware of the development, the two have been asked to move ahead with contract signing for the sleeper design Vande Bharat trains tender in which the consortium was the lowest bidder.

"The issues between the companies will soon be resolved and contracts for making for trains will be signed," the official told ET. People part of the negotiation process said that some positive signals are coming from the Indian Railways that is keen to award the contract at the price quoted by the TMH-RVNL consortium.

At ₹120 crore per train, the TMH-RVNL bid was significant-

ly lower than that of competitors, including BHEL-Titagarh (₹139.8 crore), Bharat Earth Movers Ltd (BEM)-Siemens (₹145 crore), Alstom Transport (₹164.52 crore), and Medha Servo Drives-Stadler Rail (₹165 crore). TMH-RVNL had bid to supply 120 of the 200 trains on offer by the Indian Railways.

The contract is for supply of train sets by 2029, and maintenance over a 15-year period. Last month the BHEL-Titagarh consortium matched the bid price of TMH-RVNL and inked a contract with Indian Railways for manufacturing the remaining 80 Vande Bharat sleeper train sets.

Sergey Medvedev, head of business development in India, TMH Group, told ET in June that RVNL is seeking to renegotiate the original arrangement agreed upon by the parties. This according to him is a deviation from an "irrevocable contract"

that was signed between them.

Responding to a query on the same, the government official quoted above said, "Government companies do not breach contracts." RVNL is a public sector undertaking company administered by the Ministry of Railways.

As on Monday, the Indian Railways has not signed the contract for the supply of trains with the TMH-RVNL consortium. "There are indications of a breakthrough this month," said a person involved with the negotiations.
