This is with reference to your email dated 12th October, 2020, informing certain discrepancies being observed by your good office, in disclosure dated 12th August, 2020, under Regulation 31 (2) of SEBI (Substantial Acquisition of Shares and Takeovers) Regulations, 2011 made by us i.e. Apollo International Limited, (one of the promoters for UFO Moviez India Ltd.), with regard to release of pledge over 22,66,417 equity Shares of the face value of Rs. 10/- each of UFO Moviez India Ltd, on 11th August, 2020 by IIFL Wealth Finance Limited (“IIFL”).

In this regard, we hereby submit to your good office the revised disclosure (as enclosed herewith) under Regulation 31 (2) of SEBI (Substantial Acquisition of Shares and Takeovers) Regulations, 2011 (“Takeover Regulations”), with regard to release of pledge over 22,66,417 equity Shares of the face value of Rs. 10/- each of UFO Moviez India Ltd, on 11th August, 2020, by IIFL Wealth Finance Limited (“IIFL”).

As mentioned earlier, these shares were earlier pledged by us i.e. Apollo International Limited, in two tranche of 12,00,000 shares and 10,66,417 shares on 12th March, 2020 and 23rd March, 2020 respectively, in favour of IIFL Wealth Finance Limited (“IIFL”), as a security for the credit facility provided by IIFL to us.

We hereby request you to please take this revised disclosure in the records, in substitution of our earlier disclosure dated 12th August, 2020.
