Sub: Intimation of meeting of the Board of Directors of Fairfield Atlas Limited ("Company") to consider proposed delisting of its shares from BSE Limited ("BSE") under the Securities Exchange Board of India (Delisting of Equity Shares) Regulations, 2009 ("Delisting Regulations")

This has reference to the captioned subject. This is to inform you that the Board of Directors of the Company has received a letter dated February 22, 2013 from TH Licensing Inc., the promoter of the Company, proposing to make a voluntary delisting offer ("**Delisting Offer**") to the public shareholders of the Company in accordance with the Delisting Regulations with a view to delist the equity shares of the Company from BSE.

Pursuant to the said letter, the Company has decided to convene a meeting of its Board of Directors on Tuesday, February 26, 2013 to consider the proposal from TH Licensing Inc.

TH Licensing Inc. currently holds 83.91% of the paid-up capital of the Company.

TH Licensing Inc. has requested the Company to expeditiously and in a manner provided in the Delisting Regulations:

- (i) Convene a meeting of the Board of Directors and approve the Delisting Offer; and
- (ii) Take requisite steps to obtain the prior approval of the shareholders of the Company to the Delisting offer by a special resolution passed through postal ballot.
