The Members,

The Resolution Professional (RP) presents to the Members the 34th Annual Report of the Company together with the Audited Standalone Financial Statements and the Auditor's Report for the Financial Year ended 31st March, 2022, which includes the Report to the Shareholders.

INITIATION OF CORPORATE INSOLVENCY RESOLUTION PROCESS (CIRP)

The National Company Law Tribunal ("NCLT"), Chandigarh Bench, vide order dated 02.02.2022 ("Insolvency Commencement Order") has initiated corporate insolvency resolution process ("CIRP") based on a petition filed by the Bank of India under Section 7 of the Insolvency and Bankruptcy Code, 2016 ("the Code"). **Mr. Darshan Singh Anand**, IP Registration No. IBBI/IPA-002/IP-N00326/2017-18/10931 was appointed as Interim Resolution Professional ("IRP") to manage the affairs of the Company in accordance with the provisions of the Code.

At the Second meeting of the committee of creditors held on 17th March 2022, Mr. Darshan Singh **Anand** had been continued as Resolution Professional (RP/ Resolution Professional) for the Pursuant the to Insolvency Commencement Order and in line with the provisions of the Code, the powers of the Board of Directors were suspended and the same were to be exercised by RP. The Company had received 5 Resolution Plans which were put to vote before the Committee of Creditors ("CoC"). The Committee of Creditors (CoC) has approved the resolution plan submitted by M/s Arcbolt Space and Foods Private Limited, with a requisite majority of the voting share as per the Insolvency and Bankruptcy Code , 2016 (IBC) in the 11th Meeting of the Committee of Creditors (COC) held on Thursday 25th August 2022. The application for approval of the Resolution Plan by NCLT under Section 30(6) of the Insolvency and Bankruptcy Code, 2016 was filed on 31.10.2022 and the same is pending adjudication before Adjudicating Authority.

Since the company is under Corporate Insolvency Resolution Process (CIRP), as per Section 17 of the Insolvency & Bankruptcy Code, from the date of appointment of the Resolution Professional.

- (a) the management of the affairs of the company shall vest in the Resolution Professional.
- (b) The powers of the Board of Directors of the company shall stand suspended and be exercised by the Resolution Professional.
- (c) the officers and managers of the company shall report to the Resolution Professional andprovide access to such documents and records of the company as may be required by the Resolution Professional.
- (d) the financial institutions maintaining accounts of the company shall act on the instructions of the Resolution Professional in relation to such accounts and furnish all information relating to the company available with them to the Resolution Professional.

Approval of the Financial Statements 2021-22 and the Report to the Shareholders

As the powers of the Board of Directors have been suspended, the financial statements have not been approved by the Board of Directors. However, the same has been approved and signed by RP, Signed by Two Directors& signed by the Company Secretary according to the Companies Act, 2013. The position of CFO had become vacant pursuant to the resignation of the former on March 31, 2021.

ROLE OF THE COMMITTEE

The Committee has been formulated to perform the following works: -

- The Nomination and Remuneration Committee shall identify persons who are qualified to become directors and who may be appointed to senior management in accordance with the criteria laid down in the Companies Act, 2013 and rules made there under and all other provisions applicable, if any and recommend to the Board their appointment and removal. It shall carry out an evaluation of every director's performance.
- The Nomination and Remuneration Committee shall formulate the criteria for determining qualifications, positive attributes and independence of a director and recommend to the Board a policy, relating to the remuneration for the directors, key managerial personnel and other employees.
- To carry out an evaluation of every Director's performance.
- To carry out any other function as is mandated by the Board from time to time and/or enforced by any statutory notification, amendment or modification, as may be applicable.
- To perform such other functions as may be necessary or appropriate for the performance of its duties.

CRITERIA FOR APPOINTMENT OF DIRECTOR

Any person who wishes to be appointed as a Director of the Company needs to fulfil the following criteria:

- His appointment must not be in Contravention of any provision of the Companies Act, 2013 and rules made there under or under any other applicable laws, if any.
- The appointment shall be subject to applicable Regulation of the SEBI (Listing Obligation and Disclosure Requirement) Regulations, 2015.
- 3. The person who wishes to be appointed as a Director must have relevant experience in the industry similar to the business of the Company or hold relevant qualifications in this regard. The Committee has the discretion to decide whether qualification, expertise and experience



possessed by a person are sufficient / satisfactory for the concerned position.

The Director will be eligible for appointment only if he has attained the age of twenty-one years.

INDEPENDENT DIRECTOR

The Independent Director must fulfil the following criteria:-

- His appointment must not be in Contravention of Section 149 of the Companies Act, 2013 and rules made there under and all the applicable laws, if any.
- The appointment shall be subject to applicable Regulation of the SEBI (Listing Obligation and Disclosure Requirement) Regulations, 2015.
- 3. He shall possess appropriate skills, experience and knowledge in one or more fields of finance, law, management, sales, marketing, administration, research, corporate governance, technical operations, or other disciplines related to the Company's business,

TERM/TENURE

Managing Director/Whole-time Director:
 The Company shall appoint or re-appoint any person as its Executive Chairman, Managing Director or Executive Director for a term not exceeding five years at a time. No reappointment shall be made earlier than one year before the expiry of the term.

2. Independent Director: -

- a) An Independent Director shall hold office for a termup to five consecutive years on the Board of theCompany and will be eligible for reappointmenton passing of a special resolution by the Companyand disclosure of such appointment in the Board'sreport.
- b) No Independent Director shall hold office for more than two consecutive terms, but such Independent Director shall be eligible for appointment after expiry of three years of ceasing to become an Independent Director.

Provided that an Independent Director shall not, during the said period of three years, be appointed in or be associated with the Company in any other capacity, either directly or indirectly.

However, if a person who has already served as an Independent Director for 5 years or more in the Company as on October 1, 2014, or such other date as may be determined by the

- Committee as per regulatory requirement; he/ she shall be eligible for appointment for one more term of 5 years only.
- c) At the time of appointment of an Independent Director it should be ensured that the number of Boards on which such Independent Director serves is restricted to seven listed companies as an Independent Director and three listed companies as an Independent Director in case such a person is serving as a Whole-time Director of a listed Company or such other number as may be prescribed under the Act.

REMOVAL

Due to reasons for any disqualification mentioned in the Companies Act, 2013 or under any other applicable Act, rules and regulations there under, the Committee may recommend, to the Board with reasons recorded in writing, removal of a Director, KMP or Senior Management Personnel subject to the provisions and compliance of the said Act, rules and regulations.

RETIREMENT

The Director, KMP and Senior Management Personnel shall retire as per the applicable provisions of the Companies Act, 2013 and the prevailing policy of the Company. The Board will have the discretion to retain the Director, KMP, and Senior Management in the same position/remuneration or otherwise even after attaining the retirement age, for the benefit of the Company.

Policy relating to the Remuneration for the Whole-time Director, KMP and Senior Management Personnel

General:

- A. The remuneration / compensation / commission etc. to the Whole-time Director, KMP and Senior Management Personnel will be determined by the Committee and recommended to the Board for approval. The remuneration / compensation /commission etc. shall be subject to the prior/post approval of the shareholders of the Company and Central Government, wherever required.
- B. The remuneration and commission to be paid to the Whole-time Director shall be in accordance with the percentage/slabs/conditions laid down in the Articles of Association of the Company and as per the provisions of the Act.
- C. Increments to the existing remuneration/ compensation structure may be recommended by the Committee to the Board which should be



within the slabs approved by the Shareholders in the case of the Whole-time Director.

D. Where any insurance is taken by the Company on behalf of its Whole-time Director, Chief Executive Officer, Chief Financial Officer, the Company Secretary and any other employees for indemnifying them against any liability, the premium paid on such insurance shall not be treated as part of the remuneration payable to any such personnel.

Provided that if such a person is proven to be guilty, the premium paid on such insurance shall be treated as part of the remuneration.

Remuneration to Whole-time / Executive / Managing Director, KMP and Senior Management Personnel:

- a) Fixed pay: The Whole-time Director/ KMP and Senior Management Personnel shall be eligible for monthly remuneration as may be approved by the Board on the recommendation of the Committee. The breakup of the pay scale and quantum of perquisites including, the employer's contribution to P.F, pension scheme, medical expenses, club fees etc. shall be decided and approved by the Board/ the Person authorized by the Board on the recommendation of the Committee and approved by the shareholders and Central Government, wherever required.
- b) Minimum Remuneration: If, in any financial year, the Company has no profits or its profits are inadequate, the Company shall pay remuneration to its Whole-time Director in accordance with the provisions of Schedule V of the Act and if it is not able to comply with such provisions, with the previous approval of the Central Government.
- c) Provisions for excess remuneration: If any Whole-time Director draws or receives, directly or indirectly by way of remuneration any such sums in excess of the limits prescribed under the Act or without the prior sanction of the Central Government, where required, he/she shall refund such sums to the Company and until such sum is refunded, hold it in trust for the Company. The Company shall not waive recovery of such sum refundable to it unless permitted by the Central Government.

Remuneration to Non-Executive / Independent Director:

a) Remuneration / Commission:

The remuneration / commission shall be fixed as per the slabs and conditions mentioned in the

Articles of Association of the Company and as per the provisions of the Companies Act, 2013.

b) Sitting Fees:

The Non-Executive / Independent Director may receive remuneration by way of fees for attending meetings of the Board or Committee thereof.

Provided that the amount of such fees shall not exceed Rs. One Lac per meeting of the Board or Committee or such amount as may be prescribed by the Central Government from time to time.

c) Stock Options:

An Independent Director shall not be entitled to any stock option of the Company.

- d) Any remuneration paid to Non-Executive / Independent Directors for services rendered which are professional in nature shall not be considered as part of the remuneration if the following conditions are satisfied:
 - I. The Services are rendered by such Director in his capacity as the professional; and
 - II. In the opinion of the Committee, the director possesses the requisite qualification for the practice of that profession.

IMPLEMENTATION

- A. The Committee may issue guidelines, procedures, formats, reporting mechanisms and manuals in supplement and for better implementation of this policy as considered appropriate.
- B. The Committee may Delegate any of its powers to one or more of its members.

Note: - The Company has a Nomination and Remuneration Policy. Since the Company is under Corporate InsolvencyResolution Process, as per Regulation 15(2A) and (2B) ofthe Listing Regulations, Regulations 17, 18, 19, 20 and 21 of the Listina Regulations relating to committeesincluding Nomination and Remuneration Committee arenot applicable to the Company during the CIR Process.Despite the abovementioned exemption, the Companyhas a Nomination and Remuneration Committee and the composition and terms of reference of Nomination and Remuneration Committee are in compliance with theprovisions of Section 178 of the Companies Act, 2013and Listing Regulations.

CIRP

The Company came under CIRP under the provisions of the Insolvency and Bankruptcy Code, 2016 (Insolvency Code) w.e.f. 2nd February 2022 and the powers of the Board were since then vested in and arebeing exercised by RP under the Supervision of the Committee of Creditors.

The Hon'ble NCLT vide its order dated February 02, 2022 allowed initiation of CIRP of the Company and Mr. Darshan Singh Anand, IP Registration No. IBBI/IPA-002/IP-N00326/2017-18/10931 was appointed as the Interim Resolution Professional ("IRP") for the Company. The appointment of Mr. Mr. Darshan Singh Anand was confirmed/approved as the Resolution Professional ("RP") of the Company by the 02nd Committee of Creditors ("CoC") in its meeting held on 17th March, 2022 under the provisions of the Code. As per Section 17 of the Code, from the date of appointment of the IRP the management of affairs and powers of the board of directors of the Company were suspended and are exercised by IRP/RP of the Company.

The Company had received 5 Resolution Plans which were put to vote before the Committee of Creditors ("CoC"). The Committee of Creditors (CoC) has approved the resolution plan submitted by $\mathbf{M/s}$

Arcbolt Space and Foods Private Limited, with a requisite majority of the voting share as per the Insolvency and Bankruptcy Code, 2016 (IBC) in the 11th Meeting of the Committee of Creditors (COC) held on **Thursday 25th August 2022**. The application for approval of the Resolution Plan by NCLT under Section 30(6) of the Insolvency and Bankruptcy Code, 2016 was filed on 31.10.2022 and the same is pending adjudication before Adjudicating Authority.

As per regulations 15(2A) and 15(2B) of Listing Regulations, regulations 17, 18, 19, 20 and 21 of Listing Regulations which are related to the Board of Directors, Audit Committee, Nomination and Remuneration Committee, Stakeholders Relationship Committee and Risk Management Committee respectively, shall not be applicable during the Insolvency Resolution Process period in respect of a listed entity which is undergoing CIRP under the Insolvency Code. Further, the roles and responsibilities of Board of Directorsabovementioned committees as specified in regulations 17, 18, 19, 20 and 21 of the Listing Regulations are fulfilled by RP.

- c) Provisions for excess remuneration: If any Whole-time Director draws or receives, directly or indirectly by way of remuneration any such sums in excess of the limits prescribed under the Act or without the prior sanction of the Central Government, where required, he/she shall refund such sums to the Company and until such sum is refunded, hold it in trust for the Company. The Company shall not waive recovery of such sum refundable to him unless permitted by the Central Government.

Remuneration to Non-Executive / Independent Director:

a) Remuneration / Commission:

The remuneration/commission shall be fixed as per the slabs and conditions mentioned in the Articles of Association of the Company and the Act.

b) Sitting Fees:

The Non-Executive / Independent Director may receive remuneration by way of fees for attending meetings of the Board or Committee thereof.

Provided that the amount of such fees shall not exceed Rs. One Lac per meeting of the Board or Committee or such amount as may be prescribed by the Central Government from time to time.



c) Stock Options:

An Independent Director shall not be entitled to any stock option of the Company.

- d) Any remuneration paid to Non-Executive/Independent Directors for services rendered, which are of professional in nature shall not be considered as part of the remuneration if the following conditions are satisfied:
- The Services are rendered by such Director in his capacity as the professional; and
- ii) In the opinion of the Committee, the director possesses the requisite qualification for the practice of that profession.

e) Details of remuneration of Directors

Dematerialization of shares

The Members of Vikas WSP Limited Report on the Audit of the Financial Statements Corporate Insolvency Proceedings as per Insolvency and Bankruptcy Code, 2016 (IBC)

The National Company Law Tribunal ("NCLT"), Chandigarh Bench, vide their order delivered on February 2nd, 2022 ("Insolvency Commencement Date") has admitted the petition filed by financial creditor of the company for initiation of Corporate Insolvency Resolution Process ("CIRP") u/s 7 of the Insolvency and Bankruptcy Code, 2016 ("the code") and has appointed Mr. Darshan Singh Anand, Registration No. IBBI/IPA-002/IP-N00326/2017-18/10931 as Interim Professional ("IRP") to manage the affairs of the company in accordance with the provisions of the code. In the second meeting of Committee of Creditors ("COC") held on March 17th, 2022, Mr. Darshan Singh Anand has been confirmed as Resolution Professional ("RP") for the company. Pursuant to NCLT order for commencement of CIRP and in line with the provisions of the Code, the powers of the Board of directors shall stand suspended and be exercised by IRP/RP.

We have been informed by RP that the record of the Company is not handed over to RP completely and hence application u/s 19(2) of the IBC has been submitted to NCLT. Further, as informed by the management at the time of initiaition of the CIRP proceedings vide email dated 15.02.2022 that due to ransom ware attack the tally data, fixed assets register and other relevant records before 01.04.2021 were not available.

Qualified Opinion

We have audited the accompanying financial statements of Vikas WSP Limited ("the Company"), which comprise the Balance Sheet as at March 31, 2022, and the Statement of Profit and Loss (including Other Comprehensive Income), the Cash Flow Statement and the Statement of Changes in Equity for the year then ended, and a summary of significant accounting policies and other explanatory information (hereinafter referred to as the "financial statements").

In our opinion and to the best of our information and according to the explanations given to us, except for the possible effects of the matter described in the Basis for Qualified Opinion section of our report, the aforesaid financial statements give the information required by the Companies Act, 2013 ("the Act") in the manner so required and give a true and fair view in conformity with the Indian Accounting Standards prescribed under section 133 of the Act read with the Companies (Indian Accounting Standards) Rules, 2015, as amended, ("Ind AS") and other accounting principles generally accepted in India, of the state of affairs of the Company as at March 31, 2022, and its loss (including other comprehensive loss), its cash flows and the changes in equity for the year ended on that date.

Basis for Qualified Opinion

We conducted our audit of the financial statements in accordance with the Standards on Auditing specified under section 143(10) of the Act (SAs). Our responsibilities under those Standards are

further described in the Auditor's Responsibility for the Audit of the Financial Statements section of our report. We are independent of the Company in accordance with the Code of Ethics issued by the Institute of Chartered Accountants of India (ICAI) together with the ethical requirements that are relevant to our audit of the financial statements under the provisions of the Act and the Rules made there under, and we have fulfilled our other ethical responsibilities in accordance with these requirements and the ICAI's Code of Ethics. We believe that the audit evidence obtained by us is sufficient and appropriate to provide a basis for our audit opinion on the financial statements.

- 1. For the reasons as specified in the paragraph 1 above of the Audit Report, the company has not taken into consideration any impact on the carrying value of tangible assets, if any, in the preparation of Financial Results as required by Ind-AS 10 on the "Events after the reporting period". Further, the company has also not made full assessment of its impairment in their fair value as required by Ind AS 36 on the impairment of assets, if any, as on 31st March 2022 in the value of tangible assets. The company continues not to assess the impairment of the carrying value of the tangible assets. Therefore, we are unable to comment on the consequential impairment, if any, that is required to be made in the carrying value of property, plant and equipment.
- 2. For the reasons as specified in the paragraph 1 above of the Audit Reportand pending comprehensive review of carrying amount of all assets (including balances lying under Goods & Service Ta x and oth er sta tutory authoritie s) & liabilities including trade receivables, advances paid, trade payables, advances received, other short term liabilities, etc. as a t 31st Ma rch, 2022which ar e un confirmed and no documentary evidence have be en made available to verify/ confirm the samealong with non-provision for impairment of carrying value of the assets and write back of liabilities if any due to pending implementation of the approved resolution plan by NCLT, we are unable to comment that whether any adjustment is required in the carrying amount of such assets and liabilities and c onsequential impac t, if any, on the reported losses for the year ended March 31, 2022. Non determination of fair value of financial assets & liabilities and impairme nt in carrying a mount for other a ssets and liabilities are not in compliance with Ind AS 109 "Financial Instruments", Ind AS 10 "Events after the Reporting Period", Ind AS 36 "Impairment of Assets" and I nd AS 37 "Provisions, Contingent Liabilities & Contingent Assets".
- 3. The financial creditors and the operational creditors, as part of CIRP have submitted their claims to IRP which is un der reconciliation with the amounts as appearing in the books of accounts. A ccordingly, to the extent the process for submission and reconciliation of claims as on the Insolvency Commencement Date remains an ongoing process, no provision/accounting adjustments are made in the books of accounts in respect of excess/short or non receipt of claims in the case of financial and operational creditors." Hence,



- consequential impact, if any, on the financial results is not currently ascertainable.
- 4. For the reasons as specified in the paragraph 1 above of the Audit Report, the Company has not produced Fixed Asset Register. Accordingly, we can not comment on accuracy of the value of Property, Plant and Equipment, calculation of current de preciation and its possible impact on Financial Statements. Further, the Company has written off Capital Work in Progress amounting to Rs. 1156.33 lacs, being non-existent, to the Statement of Profit and Loss whereas no sufficient and appropriate audit evidence have been produced to substantiate the same as well as nature of expense whether it is capital or revenue. Hence, we are unable to comment on the same.
- 5. The Company has written of amount of Rs. 157.38 lacs of electricity security deposit as Rs. 109.74 lacs being adjusted with electricity expenses payable of previous years and Rs. 47.64 lacs being non-existent, to the Statement of Profit and Loss whereas no sufficient and appropriate audit evidence have been produced to substantiate the charge made in Statement of Profit and Loss.
- 6. For the reasons as specified in the paragraph 1 above of the Audit Report,Sale of Fixed Assets amounting to Rs. 9.85 lacs has been booked on the Financial Statements for which no detail of purchase and gain or loss on sale has been provided to us. Consequently, no effect in the financial statements has been considered on the accumulated depreciation of sold out asset
- 7. The Share Application Money pending allotment amounting to Rs. 850 lacs is outstanding the financial statements as on 31st March 2022 which has neither been refunded nor allotted as per the requirements of section 42 of the Companies Act, 2013. Co rrespondingly, pendin g CIRP pro ceedings be ing undertaken, no interest provision of Rs. 102 lacs has been made on the outstanding amount during the year.
- 8. We have been informed by the Resolution professional that certain information i ncluding the m inutes of meetings of Committee of C reditors a nd the o utcome of c ertain procedures carried out as a part of CIRP are confidential in nature and could not be shared with anyone other than the

- Committee of Creditors and NCLT. Accordingly, we are unable to comment on the possible financial impact, presentation and disclosures, if any, that may arise if we have been provided access to that information.
- 9. There are 16,977,332 shares held in the name of Mr B D Agarwal who was deceased on 21.09.2020, No transmission of s hares of t he d eceased shareholder h as b een m ade a s required under section 56 of the Companies Act 2013.
 - We further report that, the impact of the above mentioned observations, except wherever quantified, on the financial statements could not be ascertained, in the absence of relevant details on record.

Emphasis of Matter

We draw attention to the following:

The Company has incurred continuous losses, current liabilities exceeding its current assets, default in repayment of borrowings and de fault in payment of reg ulatory and statutory du es. This situation indicates that a material uncertainty exists that may cast significant doubt on the Company's ability to continue as a going concern. The a ccounts how ever have been p repared by the management on a going concern basis for the reason as stated. The COC in its meeting dated 25th August 2022 have approved the Resolution p lan submitted by M/s Arc bo lt S pace and F oods Private L imited. Pursuant to p endency of its approval by the NCLT, we are unable to obtain sufficient and appropriate audit evidence regarding management's use of the going concern basis of ac counting in the preparation of the stan dalone financ ial statements, in view of ongoing CIRP and matters pending before regulatory authorities, the outcome of which cannot be p resently ascertained

Our report is not qualified on the above matters.

Key Audit Matter

Key audit matters are those matters that, in our professional judgment, were of most significance in our audit of the financial statements of the current period. These matters were addressed in the context of our audit of the financial statements as a whole, and in forming our opinion thereon, and we do not provide a separate opinion on these matters.

The Key audit matter

- The company is exposed to a variety of different Central and state laws, regulations and interpretations thereof. In this regulatory environment, there is an inherent risk of litigations and claims.
- In the normal course of business, provisions and contingent liability disclosures for litigations and claims may arise from direct and indirect tax proceedings, legal proceedings, including regulatory and other government/department proceedings, as well as investigations by authorities and commercial claims.
- These estimates could change substantially over time as new facts emerge and each legal case progresses
- Given the inherent complexity and magnitude of potential exposures across the Company and the judgement necessary to estimate the amount of provisions required or to determine required disclosures, this is a key audit matter.

How the matter was addressed in our audit

Our procedures included:

Inquiring the status of significant known actual and potential litigation with the IRP who have knowledge of these matters and critically assessing their responses.

- Obtaining, on a sample basis, written responses from the IRP, containing
 their views and conclusions on material exposures and any related
 litigation and considered the same in evaluating the appropriateness of
 the Company's provisions or disclosures on such matters.
- Reading the latest correspondence between the Company and the various tax/legal authorities or plaintiffs and attorneys where applicable, for matters selected on sample basis for detailed evaluation.
- Challenging the decisions and rationale for provisions held or for decisions not to record provisions or make disclosures.
- For those matters where IRP concluded that no provisions should be recorded, we have reviewed the adequacy and completeness of the Company's disclosures.



Responsibility of Management for the Financial Statements

The Company's Board of Directors is responsible for the matters stated in section 134(5) of the Companies Act, 2013 ("the Act") with respect to the preparation of these financial statements that give a true and fair view of the financial position, financial performance, (changes in equity) and cash flows of the Company in accordance with the accounting principles generally accepted in India, including the accounting Standards specified under section 133 of the Act. This responsibility also includes maintenance of adequate accounting records in accordance with the provisions of the Act for safeguarding of the assets of the Company and for preventing and detecting frauds and other irregularities; selection and application of appropriate implementation and maintenance of accounting policies; making judgments and estimates that are reasonable and prudent; and design, implementation and maintenance of adequate internal financial controls, that were operating effectively for ensuring the accuracy and completeness of the accounting records, relevant to the preparation and presentation of the financial statement that give a true and fair view and are free from material misstatement, whether due to fraud or

In preparing the financial statements, management is responsible for assessing the Company's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the Company or to cease operations, or has no realistic alternative button do so.

Those Board of Directors are also responsible for overseeing the company's financial reporting process

Auditor's Responsibility for the Audit of the Financial Statements

Our responsibility is to conduct an audit of the entity's financial statements in accordance with Standards on Auditing issued by ICAI and to issue an auditor's report. However, because of the matters described in the Basis for Disclaimer of Opinion section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are independent of the entity in accordance with the ethical requirements in accordance with the requirements of the Code of Ethics issued by ICAI and the ethical requirements as prescribed under the laws and regulations applicable to the entity.

Report on Other Legal and Regulatory Requirements

- 1. As required by the Companies (Auditor's Report) Order, 2016 ("the Order") issued by the Central Government in terms of Section 143(11) of the Act, we give in "Annexure A" statement on the matters specified in paragraphs 3 and 4 of the Order.
- 2. As required by Section 143(3) of the Act, based on our audit we report that:
- a) As mentioned in the Qualified Opinion paragraph, we were unable to obtain all the information and explanations which to the best of our knowledge and belief were necessary for the purposes of our audit.

- b) Due to the possible effects of the matters described in the Basis of Qualified Opinion paragraph, we are unable to state whether proper books of account as required by law have been kept by the Company so far as it appears from our examination of those books.
- c) The Balance Sheet, the Statement of Profit and Loss including Other Comprehensive Income, the Cash Flow Statement and Statement of Changes in Equity dealt with by this Report are in agreement with the books of accounts.
- d) In our opinion, the aforesaid financial statements comply with the Ind AS specified under Section 133 of the Act except for the matters as described in the basis for Qualified Opinion paragraph.
- e) The matters described under the basis for disclaimer of opinion paragraph above and Qualified Opinion paragraph of "Annexure B" to this report in our opinion, may have an adverse effect on functioning of the Company and on the amounts disclosed in standalone financial statements of the Company.

NOTE NO. 1 SIGNIFICANTACCOUNTING POLICIES AND NOTESON FINANCIAL STATEMENTS

I) CORPORATE INFORMATION

The Company Vikas WSP Limited was established in 1988. The company is engaged in the business of manufacturing and trading of Guar Gum. The Company has its registered office at Railway Road, Siwani, Haryana and its corporate office (principal place of business) at Sri Ganganagar, Rajasthan, India. The company is listed at Bombay Stock Exchange (BSE) vide ISIN: INE706A01022.

II) SIGNIFICANT ACCOUNTING POLICIES a. BASIS OF PREPARATION:

These financial statements are prepared in accordance with Indian Accounting Standard(Ind AS), under the historical cost convention on accrual basis except for certain financial instruments which are measured at fair values, the provisions of the Companies Act, 2013 ("theAct") and guidelines issued by the Securities and Exchange Board of India (SEBI). The IndAS are prescribed under Section 133 of the Act read with Rule 3 of the Companies (Indian Accounting Standards) Rules, 2015 and relevant amendment rules issued thereafter from time to time.

Accounting policies have been consistently applied except where a newly-issued accounting standard is initially adopted or a revision to anexisting accounting standard requires a changein the accounting policy hitherto in use. As theyear-end figures are taken from the source androunded to the nearest lacs, the figuresreported for the previous quarters might notalways add up to the year-end figures reported in this statement.

The financial statements are presented in INR, the functional currency of the company. Itemsincluded in the financial statements of thecompany are recorded using the currency of theprimary economic environment in which thecompany operates (the 'functional currency')

Transactions and balances with values belowthe rounding off norm adopted by the companyhave been reflected as "0" in the relevant notesto these financial statements.

The National Company Law Tribunal ("NCLT"), Chandigarh Bench, vide their order delivered on February 2nd, 2022

("Insolvency Commencement Date") has initiated Corporate Insolvency Resolution Process ("CIRP") under section 7 of the Insolvency and Bankruptcy Code, 2016 ("the Code") based on the application filed by Bank of India, the Financial Creditor of the company. Mr. Darshan Singh Anand, Registration IBBI/IPA-002/IP-No. N00326/2017-18/10931 was appointed as Interim Resolution Professional ("IRP") to manage the affairs of the company in accordance with the provisions of the code. In the second meeting of Committee of Creditors ("COC") held on 17th March, 2022 Mr. Darshan Singh Anand has been confirmed as Resolution Professional ("RP") for the company.

Further as informed above CIRP has been initiated against the company under the provisions of the Insolvency Bankruptcy Code, 2016 (IBC) by the Hon'ble NCLT vide order dated February 2nd, 2022. Pursuant to Section 17 of the IBC, the powers of Board of Directors of the Company stood suspended, and such powers are vested with IRP / RP. Accordingly, Mr. Darshan Singh Anand in his capacity as IRP / RP took control and custody of the management and operation of the company. Consequently, all actions that are deemed to be taken by Board of Directors have been given effect by the IRP/RP during the continuance of the CIRP as per the provisions of the IBC.

b. USE OF ESTIMATES AND JUDGEMENTS

The preparation of the financial statements inconformity with Ind AS requires theManagement to makeestimates, judgmentsand assumptions. These estimates, judgmentsand assumptions affect the application ofaccounting policies and the reported amounts ofassets and liabilities, the disclosures of contingent assets and liabilities at the date of the financial statements and reported amountsof revenues and expenses during the period.

The application of accounting policies thatrequire critical accounting estimates involvingcomplex and subjective judgments and the useof assumptions in these financial statementshave been disclosed. Accounting estimates could change from period to period. Actualresults could differ from those estimates. Appropriate changes in estimates are made asthe management



becomes aware of changes in circumstances surrounding the estimates. Changes in estimates are reflected in thefinancial statements in the period in whichchanges are made and, if material, their effects are disclosed in the notes to the standalone financial statements.

Estimation of uncertainties relating to the global health pandemic from COVID-19("COVID-19").

The Company has considered the possible effects that may result from the pandemicrelating to COVID-19 in the preparation ofthese financial including therecoverability statements carrying amounts of financialand non-financial assets. In developing theassumptions relating to the possible futureuncertainties in the global economic conditionsbecause of this pandemic, the Company has, atthe date of approval of these financialstatements, used internal and external sourcesof information including related information andeconomic forecasts and expects that thecarrying amount of these assets will berecovered. The impact of COVID-19 on theCompany's financial statements may differ from that estimated as at the date of approval ofthese financial statements.

c. OPERATING CYCLE FOR CURRENT ANDNON-CURRENT CLASSIFICATION

The Company presents assets and liabilities in the balance sheet based on current/non-currentclassification.

All the assets and liabilities have been classified as current or non-current, wherever applicable, as per the normal operating cycle of the Company as per the guidance set out paragraph 66 and 69 of Ind AS 1 and other criteria as setout in Division II of Schedule III of the act.

The operating cycle is the time between theacquisition of assets for processing and theirrealization in cash or cash equivalents. Basedon the nature of activities of the Company andthe normal time between acquisition of assets and their realization in cash or cash equivalents, the company has determined its operating cycleas 12 months for classification of its assets andliabilities as current and noncurrent.

d. PROPERTY, PLANT AND EQUIPMENT

Property, Plant and Equipment are stated atcost of acquisition including attributable interestand finance costs, if any, till the date ofacquisition/

installation of the assets lessaccumulated depreciation and accumulatedimpairment losses, if any.

Subsequent expenditure relating to Property, Plant and Equipment is capitalised only when itis probable that future economic benefitsassociated with the item will flow to theCompany and the cost of the item can reliably. All bemeasured other andmaintenance costs are charged theStatement of Profit and Loss as incurred. Thecost and related accumulated depreciation areeliminated from the financial statements, eitheron disposal or when retired from active use andthe resultant gain or loss are recognised in the Statement of Profit and Loss.

Capital work-in-progress, representing expenditure incurred in respect of assets underdevelopment and not ready for their intendeduse, are carried at cost. Cost includes relatedacquisition expenses, construction cost, relatedborrowing cost and other direct expenditure.

e. DEPRECIATION / AMORTISATION ON FIXEDASSETS

Depreciation on Fixed Assets is provided onstraight-line method in accordance with life ofassets specified in Part C of Schedule II to theCompanies Act, 2013 as per details givenbelow:

ASSETS ACQUIRED IN SATISFACTION OF CLAIMS

Assets acquired in satisfaction of claim has been accounted at fair value of the assets acquired and is marked down by a subsequent reduction in the Net Realisable Value, if any.

f. IMPAIRMENT OF NON-FINANCIAL ASSETS

Property, plant and equipment are evaluated forrecoverability whenever events or changes



incircumstances indicate that their carryingamounts may not be recoverable. For thepurpose of impairment testing, the recoverableamount (i.e. the higher of the fair value lesscost to sell and the value-in-use) is determinedon an individual asset basis unless the assetdoes not generate cash flows that are largelyindependent of those from other assets. In suchcases, the recoverable amount is determinedfor the Cash Generating Unit (CGU) to which the asset belongs. If such assets are consideredto be impaired, the impairment to berecognized in the Statement of Profit and Lossis measured by the amount by which thecarrying value of the assets exceeds the estimated recoverable amount of the asset. Animpairment loss is reversed in the Statement ofProfit and Loss if there has been a change inthe estimates used to determine therecoverable amount. The carrying amount ofthe asset is increased to its revised recoverableamount, provided that this amount does not exceed the amount that would carrying havebeen determined (net of accumulateddepreciation) had no impairment loss been recognized for the asset in prior years.

The impairment loss is allocated first to reducethe carrying amount of any goodwill (if any)allocated to the cash generating unit and thento the other assets of the unit, pro rata basedon the carrying amount of each asset in theunit. Recoverable amount is higher of an asset's or cash generating unit's value in use and itsfair value less cost of disposal. Value in use isestimated future cash flows expected to arisefrom the continuing use of an asset or cashgenerating unit and from its disposal at the endof its useful life discounted to their presentvalue using a post-tax discount rate thatreflects current market assessments of the timevalue of money and the risks specific to theasset. In determining fair value less costs ofdisposal, recent market transactions areconsidered. If no such transactions can beidentified, an appropriate valuation model isused. Assessment is also done at each BalanceSheet date as to whether there is any indicationthat animpairment loss recognised for an assetin prior accounting periods may no longer existor may have decreased. Basis the assessment areversal of an impairment loss for an assetother than goodwill is recognised in theStatement of Profit and Loss.

g. STOCK IN TRADE / INVENTORIES

Inventories are valued at the lower of cost andnet realisable value. Cost is computed on aweighted average basis. Cost of raw materials and stores and spares includes cost of purchaseand other costs incurred in bringing theinventories to their present location and condition. The aforesaid items are valued at netrealisable value if the finished products in whichthey are to be incorporated are expected to besold at a loss. Cost of finished goods includes allcosts of purchases, conversion costs and othercosts incurred in bringing the inventories totheir present location and condition. The netrealisable value is the estimated selling price inthe ordinary course of business less theestimated costs of completion estimatedcosts necessary to make the sale.

h. CASH AND CASH EQUIVALENTS

Cash and cash equivalents are cash, balanceswith bank and short-term (three months or lessfrom the date of placement), highly liquidinvestments that are readily convertible intocash and which are subject to aninsignificantrisk of changes in value.

i. REVENUE RECOGNITION

Revenue in respect of sale of goods isrecognized when risk and reward of ownership are transferred. The sale are accounted net ofgoods and service tax. Further goods returned or rejected are accounted in the year of return/rejection.

j. TAXES ON INCOME

Income tax expense comprises current anddeferred income tax. Income tax expense isrecognized in net profit in the Statement ofProfit and Loss except to the extent that itrelates to items recognized directly in equity, in recognized which case it is othercomprehensive income. Current income tax forcurrent and prior periods is recognized at theamount expected to be paid to or recovered from the tax authorities, using the tax tax laws that have been enacted or substantively enacted by the Balance Sheetdate. Deferred income tax assets and liabilities are recognized for all temporary differencesarising between the tax bases of assets andliabilities and their carrying amounts in thefinancial statements except when the deferredincome tax arises from the initial recognition ofgoodwill or an asset or



liability in a transactionthat is not a business combination and affectsneither accounting nor taxable profit or loss atthe time of the transaction. Deferred tax assetsare reviewed at each reporting date and are reduced to the extent that it is no longerprobable that the related tax benefit will realized. Deferred income tax assets andliabilities are measured using tax rates and taxlaws that have been enacted substantively enacted by the Balance Sheet date and are expected to apply to taxable income in the years in which those temporary differences are expected to be recovered or settled. The effectof changes in tax rates on deferred income taxassets and liabilities is recognized as income orexpense in the period that includes theenactment or the substantive enactment date.A deferred income tax asset is recognized tothe extent that it is probable that future taxableprofit will be available against which thedeductible temporary differences and tax lossescan be utilized. The company offsets current taxassets and current tax liabilities, where it has alegally enforceable right to set off therecognized amounts and where it intends eitherto settle on a net basis, or to realize the assetand settle the liability simultaneously.

k. PROVISIONS, CONTINGENT LIABILITIESAND CONTINGENT ASSETS

Provisions involving substantial degree ofestimation in measurement are recognizedwhen there is a present obligation as a result ofpast events, and it is probable that there will bean outflow of resources. Contingent liability is apossible obligation arising from past events andwhose existence will be confirmed only by theoccurrence or non-occurrence of one or moreuncertain future events not wholly within the control of the entity or a present obligation thatarises from past events but is not recognizedbecause it is not probable that an outflow ofresources embodying economic benefits will berequired to settle the obligation or the amount of the obligation cannot be measured withsufficient reliability. Contingent assets are neither recognized nor disclosed in the financial statements.

L. Employee Benefits Short Term Employee benefits

Short-term employee benefits including salariesand performance incentives, are charged tostatement of profit and loss on

anundiscounted, accrual basis during the period of employment.

Defined contribution plans

Contributions to defined contribution schemessuch as employees' state insurance, employees'provident fund, employee pension scheme etc.are charged as an expense based on theamount of contribution required to be made asand when services are rendered by theemployees. Company's provident fundcontribution, of in respect certain employees, ismade to а Government administered fund andcharged as an expense to the Statement of Profit and Loss. The above benefits areclassified as Defined Contribution Schemes as the Company has no further defined obligationsbeyond the monthly contributions.

Defined benefit plans

The Company also provides for retirement/postretirement benefits in the form of gratuity, compensated absences (in respect certainemployees) and medical benefits (in respect ofcertain employees) including to the employeesof group companies. For defined benefit plans, the amount recognised as 'Employee benefitexpenses' in the Statement of Profit and Loss is the cost of accruing employee benefitspromised to employees over the year and thecosts of individual events such as past/futureservice benefit changes settlements (suchevents are recognised immediately in the Statement of Profit and Loss). The amount ofnet interest expense calculated by applyingtheliability discount rate to the net defined benefitliability or asset is charged or credited to'Finance costs' in the Statement of Profit andLoss. Any differences between the expectedinterest income on plan assets and the returnactually achieved, and any changes in theliabilities over the year due to changes inactuarial assumptions experienceadjustments within the plans, are recognisedimmediately in 'Other comprehensive income'and subsequently not reclassified to theStatement of Profit and Loss. The definedbenefit plan surplus or deficit on the BalanceSheet date comprises fair value of plan assetsless the present value of the defined benefitliabilities using a discount rate by reference tomarket yields on Government bonds at the endof the reporting period. All defined benefit plansobligations are determined based on valuations, as at the Balance Sheet date, made by independent actuary using the



projected unitcredit method. The classification of theCompany's net obligation into current and non-current is as per the actuarial valuation report.

Termination benefits

Termination benefits, in the nature of voluntaryretirement benefits or termination benefitsarising from restructuring, are recognised in the Statement of Profit and Loss. The Companyrecognises termination benefits at the earlier of the following dates:

- (a) when the Company can no longer withdrawthe offer of those benefits; or(b) when the Company recognises costs for arestructuring that is within the scope of IndAS 37: Provisions,
- (b) Contingent Liabilities and Contingent Assets and involves thepayment of termination benefits. Benefits falling due more than 12 monthsafter the end of the reporting period are discounted to their present value

Remeasurements of Net Defined BenefitPlans:

Differences between the interest incomeon plan assets and the return actually achieved, and any changes in the liabilities over the yeardue to changes in actuarial assumptions or experience adjustments within the plans, are recognised in other comprehensive income and are adjusted to retained earnings.

m. FINANCIAL INSTRUMENTS

Financial assets are recognised when the Company becomes a party to the contractual provisions of the instrument.

Financial Assets Initial Measurement:

All financial assets are recognised initially at fair value plus, in the case offinancial assets not recorded at fair value throughprofit or loss, transaction costs that are attributable to the acquisition of the financial asset. Purchasesor sales of financial assets that require delivery of assets within a time frame established by regulation

or convention in the market place (regular waytrades) are recognised on the trade date, i.e., thedate that the Company commits to purchase or sellthe asset.

Subsequent Measurement:

Subsequent measurement is determined withreference to the classification of therespective financial assets and the contractual

cash flowcharacteristic of thefinancial assets, the companyclassifies financial assets as subsequently measuredatamortized cost, fair value through othercomprehensive income or fair value throughprofitand loss.

Financial asset is measured at amortised cost

A financial asset is measured at amortised cost if itis held within a business modelwhose objective is tohold the asset in order to collect contractual cashflows and thecontractual terms of the financialasset give rise onspecified dates to cash flowsthatare solely payments of principal and interest onthe principal amount outstanding.

Financial Assets at fair value through otherComprehensive Income (FVOCI)

Financial Assets carried at amortised costA financial asset is measured at FVOCI if it is heldwithina business model whose objective isachieved by both collecting contractual cash flowsand selling financial assets and the contractualterms of the financial asset give rise on specifieddates tocash flows that are solely payments ofprincipal and interest on the principal amountoutstanding.

Financial Assets at fair value through profit or loss (FVTPL)

A financial asset which is not classified in any of theabove categories are measured at FVTPL Debtinstruments included within the FVTOCI categoryare measured at fair value with all changesrecognized in profit and loss. However currently the company does not have any financial instrument in this category.

Equity Investment

All equity investments in scope of Ind AS 109 are measured at fair value except unquoted equityinvestments which are stated at cost. Equity instruments which are held for trading are classifiedas at FVTPL. For other equity instruments, thecompany decides to classify the same either as atFVTOCI or FVTPL. The company makes suchelection on an instrument by instruments basis. TheClassification is made on initial recognition and is irrevocable.

If the company decides to classify an equityinstrument as at FVTOCI, all fair value changes onthe instrument, excluding dividends are recognized other comprehensive income. There is norecycling of the amount from other comprehensive income to profit and loss even on sale of investment. However, the company may



transfer

the cumulative gain or loss within equity.

Equity instruments included within the FVTPLcategory are measured at fair value with allchanges recognized in the profit or loss.

De-recognition of Financial Assets

The Company de-recognises a financial asset onlywhen the contractual rights to the cash flows from the asset expire, or it transfers the financial assetand substantially all risks and rewards of ownership of the asset to another entity.

If the Company neither transfers nor retains substantially all the risks and rewards of ownership and continues to control the transferred asset, the Company recognize sits retained interest in the assets and an associated liability for amounts it may have to pay.

If the Company retains substantially all the risksand rewards of ownership of a transferred financialasset, the Company continues to recognise thefinancial asset and also recognises a collateralisedborrowing for the proceeds received.

Financial Liabilities

Financial liabilities are classified, at initialrecognition, as financial liabilities at fairvaluethrough profit or loss, loans and borrowings andpayables as appropriate. Allfinancial liabilities are recognised initially at fair value and, in the case of loans and borrowings and payables, net of directlyattributable transaction costs.

Borrowings:

After initial recognition, interest-bearing loans and borrowings are subsequently measured at fair value.

• Financial Guarantee Contracts:

Financial guarantee contracts issued by the Company arethose contracts that require a payment to bemade to reimburse the holder for a loss it incursbecause the specified debtor fails to make apayment when due in accordance with theterms of a debt instrument. Financial guaranteecontracts are recognised initially as a liability atfair value, adjusted for transaction costs thatare directly attributable to the issuance of theguarantee. Subsequently, the liability ismeasured at the higher of the amount of lossallowance determined as per impairment

requirements of Ind AS 109 and the amountrecognised less cumulative amortisation.

• De-recognition of Financial Liabilities:

Financial Liabilities are removed from thebalance sheet when the obligation specified inthe contract is discharged, cancelled or expired. The difference between the carrying amount of a financial liability that has been extinguished or transferred to another party and the consideration paid, including any non cash assets transferred or liabilities assumed, is recognized the Statement of Profit and Loss asother gains/(losses).

Offsetting Financial Instruments:

Financial Assets and Financial Liabilities are offset andthe net amount is reported in the Balance Sheetif there is a currently enforceable legal righttooffset the recognised amounts and there is anintention to settle on a net basis; to realise theassets and settle the liabilities simultaneously.

n. FAIR VALUE MEASUREMENT

The Company measures financial assets and financial liability at fair value at each balance sheet date.

Fair value is the price that would be received tosell an asset or paid to transfer aliability in anorderly transaction between market participantsat the measurement date. The fair valuemeasurement is based on the presumption thatthe transaction to sell the asset or transfer the liability takes place either:

- In the principal market for the asset orliability, or
- In the absence of a principal market, in the mostadvantageous market for the asset or liability

The principal or the most advantageous marketmust be accessible by the Company. The fair valueof an asset or a liability is measured using theassumptions that market participants would usewhen pricing the asset or liability, assuming thatmarket participants act in their economic best interest.

A fair value measurement of a non-financial assettakes into account a market participant's ability togenerate economic benefits by using the asset in itshighest and best use or by selling it to anothermarket participant that would use the asset initshighest and best use. The Company



uses valuationtechniques that are appropriate in thecircumstances and for which sufficient data areavailable to measure fair value, maximising the useof relevant observable inputs and minimizing the use of unobservable inputs.

All assets and liabilities for which fair value ismeasured or disclosed in the financial statementsare categorised within the fair value hierarchy, described as follows, based on the lowest levelinput that is significant to the fair value measurement as a whole:

- Level 1 Quoted (unadjusted) market prices inactive markets for identical assets orliabilities
- Level 2 Valuation Techniques for which thelowest level input that is significant to the fairvalue measurement is directly or indirectlyobservable
- Level 3 Valuation Techniques for which the lowest level input that is significant to the fair value measurement is unobservable. For assets and liabilities that are recognised in the financial statements on a recurring basis, Company determines whether transfers haveoccurred between levels in the hierarchy byre-assessing categorisation (based thelowest level input that is significant to the fairvalue measurement as a whole) at the end ofeach reporting period.

The Management analyses the movements in the values of assets and liabilities which are required to be remeasured or re-assessed asper the Company's accounting policies. For this analysis, the Management verifies the majorinputs applied in the latest valuation by agreeing the information in the valuation computation and other relevant documents.

r. FINANCIAL RISK MANAGEMENT OBJECTIVESAND POLICIES

Financial Risk Factors

The Company's financial risk management is anintegral part of how to plan and execute itsbusiness strategies. The Company's overall riskmanagement program focuses on theunpredictability of financial markets and seeks tominimise potential adverse effects on the financial performance of the Company.

The Company's business activities are exposed to avariety of financial risks, namely liquidity risk, market risk, credit risk and commodity risk. TheCompany's senior management has the overallresponsibility for establishing and governing theCompany's risk management framework. TheCompany has constituted a Risk Management

Committee, which is responsible for developing andmonitoring the Company's risk managementpolicies. The Company's risk



management policiesare established to identify and analyse the risksfaced by the Company, to set and monitorappropriate risk limits and controls, periodicallyreview the changes in market conditions and reflectthe changes in the policy accordingly. The key risksand mitigating actions are also placed before the Audit Committee of the Company.

Market Risk

Market risk is the risk that changes in marketprices, such as foreign exchange rates, interestrates and equity prices will affect the Company'sincome or the value of its holdings of financialinstruments. The objective of market riskmanagement is to manage and control market risk exposures within acceptable parameters, while optimising the return.

Interest Rate Risk

The Company has financial liabilities which are atfixed interest rates and is therefore not exposed tothe risks associated with the effects of fluctuation ininterest rates.

Foreign Exchange Risk

Foreign currency risk is the risk that the fair valueor future cash flows of a financial instrument willfluctuate because of changes in foreign exchangerates. As the company does not deal in forextransaction, there is not foreign risk.

Credit Risk

Credit Risk represents the potential loss that theCompany would incur if counterparties fail toperform pursuant to the terms of their obligations to the Company. The Company limits its credit riskby carrying out transactions. The maximum exposure to credit risk is represented by thecarrying amount of each financial asset in the statement of financial position. There is no risk interms of Bank Balances, since the counterparty is are putable bank with high quality external creditratings.

Liquidity risk

Liquidity risk is the risk that the Company will notbe able to meet its financial obligations as they falldue. The Company's approach to managing liquidity is to ensure, as far as possible, that it will alwayshave sufficient liquidity to meet its liabilities whendue, under both normal and stressed conditions, without incurring unacceptable losses or riskingdamage to the Company's reputation. The Company manages

liquidity risk by maintaining adequatereserves, by continuously monitoring forecast and actual cash flows and matching the maturity profiles of the financial assets and liabilities.

s. Foreign Currencies:

Foreign currency transactions are translated into the functional currency using exchange rates at the date of the transaction. Foreign exchange gains and losses from settlement of these transactions are recognised in the Statement of Profit and Loss. Foreign currency denominated monetary assets and liabilities are translated into functional currency at exchange rates in effect at the balance sheet date, the gain or loss arising from such translations are recognised in the statement of profit and loss.

- i) Valuations are based on certain assumptions, which are dynamic in nature and vary over time. As such company is exposed to various risks as follow-
- a) Salary Increases Actual salary increases will increase the Plan's liability. Increase in salary increase rate assumption in future valuations will also increase the liability.
- b) Investment Risk If Plan is funded then assets liabilities mismatch & actual investment return on assets lower than the discount rate assumed at the last valuation date can impact the liability.
- c) Discount Rate: Reduction in discount rate in subsequent valuations can increase the plan's liability.
- d) Mortality & disability Actual deaths & disability cases proving lower or higher than assumed in the valuation can impact the liabilities.
- e) Withdrawals Actual withdrawals proving higher or lower than assumed withdrawals and change of withdrawal rates at subsequent valuations can impact Plan's liability.
- ii) During the year the Company has recorded an expense of Rs 0.00 lacs (previous year Rs. 67.08 lacs) towards provident fund, a defined contribution plan.
- iii) Leaves are encashed at the end of the year and not carried forwarded.
- iv) Post employment benefits are determined by an Independent Actuary on overall basis and hence have not been separately provided for key management personnel.

35. Settlement Claim

The Company had filed a legal suit in US Court of law against M/s Economy Polymers and Chemicals, USA ("Economy Polymers') in the month of November 2013 for non performance of purchase orders issued by Economy Polymers. During the year 2014-15, the Company had entered into a settlement for USD 80 Million, Equivalent Rs. 494,82.62 lacs with Economy Polymers against their claim for compensation. The Company had recognized Rs. 474,46.08 lacs in the Statement profit and loss and balance of Rs. 2036.54 lacs has been adjusted against outstanding receivable for seed distribution from Economy Polymers as per the settlement agreement. In turn, to discharge to the Company's liability towards non-performance of agreements for purchase of material for Economy Polymers, the Company had settled with suppliers for Rs. 385,00.00 lacs. The same had been recognized in the statement of profit and loss during the financial year 2014-15 on accrual basis.

However, subsequent to payment of USD 40 million (Equivalent INR 24965.80 lacs, in July 2015 Economy Polymers stopped paying the balance instalments due as per the aforesaid settlement agreement. Consequently, due to non recovery of the said dues to the extent of USD 40 million approximately INR 26,028.00 lacs, the Company has filed a court case against Economy Polymers in United States District court for the Southern District of Texas Houston Division, for recovery of balance USD 40 million (Equivalent INR 26028.00 lacs) which was dismissed by court resultantly, the company went into appeal in higher court. Considering the ongoing litigation the receivable has been classified under other non-current assets.

- **36 (a) (i)** The Company was availing various export credit facilities for Export from Punjab National Bank, Union Bank of India and Bank of India under consortium arrangements. The aforementioned credit facilities of the Company were classified as Non-Performing Assets (NPA) for Punjab National Bank on 30/11/2019, Union Bank of India on 31/03/2016 and Bank of India on 31/12/2016. However during the current year the Company has not repaid any loans to the aforesaid banks.
- **36 (a) (ii)** The rate of interest on the working capital loans from banks have been considered as 15.50% p.a. as per the terms of sanction. The unsecured loans of the Company are interest free and repayable within 12 months, upon demand by the lender.
