DELHI CHIEF MINISTER and AAP supremo Arvind Kejriwal has moved the Gujarat High Court appealing against the quashing of a Central Information Commission (CIC) order that directed the Gujarat University (GU) to "search for information" about Prime Minister Narendra Modi's educational degrees.

On March 31, a single judge bench of Justice Biren Vaishnav had quashed the CIC order on the ground that the educational degrees of a student fall under the exemption of disclosure of personal information granted under the Right to Information (RTI) Act.

The AAP leader moved the appeal on December 15 after

Justice Vaishnav rejected his review plea in November.

Justice Vaishanav had held that the CIC "transgressed its jurisdiction" and "embarked into an arena of political thicket and ventured into judicial activism on being overwhelmed by the fact that the information is sought by a citizen occupying the post of Chief Minister and thus, is liable to be disclosed". The court had termed the CIC

order a "fishing and roving enquiry" and also imposed costs of Rs 25,000 on Kejriwal, who had requested the information on PM's degrees under the RTI Act. While the appeal was being

ICU patient sustains burns as oxygen mask catches fire

A PATIENT sustained burns after the oxygen mask he was wearing caught fire in the intensive care unit(ICU) of a government hospital on Thursday. The cause for the fire was not immediately clear, said Dr Deepak Tiwari, medical superintendent of Guru Gobind Singh Government Hospital.

There were 15 patients in the respiratory ICU ward on the second floor at the time of the incident, but the fire was brought under control quickly and no one was shifted, he said. "A patient suffering from a lung ailment was on ventilator and being administered oxygen when his face mask caught fire. He sustained burns on the forehead and fingers," Dr Tiwari said.
