I, Pramod S M, Partner of BMP Co. LLP, Practicing Company Secretaries, had been appointed as the Scrutinizer by the Board of Directors of Sansera Engineering Limited ("the Company") to scrutinize the postal ballot through voting by electronic means ("remote e-voting"), in a fair and transparent manner and ascertain the requisite majority on the said Postal Ballot carried out pursuant to Section 110 read with Section 108 of the Companies Act, 2013 ("Act"), Rule 20 and Rule 22 of the Companies (Management and Administration) Rules, 2014 (including any statutory modification or re-enactment thereof for the time being in force) ("Rules"), Regulation 44 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations"), General Circular No. 14/2020 dated April 8, 2020, General Circular No. 17/2020 dated April 13, 2020, General Circular No. 22/2020 dated June 15, 2020, General Circular No. 33/2020 dated September 28, 2020, General Circular No. 39/2020 dated December 31, 2020, General Circular No. 10/2021 dated June, 23, 2021, General Circular No. 20/2021 dated December 8, 2021 and General Circular No. 03/2022 dated May 5, 2022 and General Circular No. 11/2022 dated December 28, 2022 and latest being General Circular No. 09/2023 dated September 25, 2023 ("collectively referred to as "MCA Circulars") and Secretarial Standard on General Meetings ("SS-2") issued by the Institute of Company Secretaries of India and any other applicable law, rules and regulations, I submit my Report, as under:

1. The Postal Ballot Notice along with Explanatory Statement under Section 102 of the Act was sent by electronic mode to those Members whose names appeared in the Register of Members as on 16th February, 2024, ("Cut-off Date") and whose e-mail address was registered with the Company/ Depositories/ Depository Participants. A copy of the Postal Ballot Notice is also available on the website of the Company (www.sansera.in), the relevant section of the website of the Stock Exchanges on which the Equity Shares of the Company are listed i.e., BSE Limited (www.bseindia.com) and National Stock Exchange of India Limited (www.nseindia.com) and on the website of E-voting agency i.e. Link Intime India Pvt. Ltd. E-Voting website at (https://instavote.linkintime.co.in), the remote e-voting service provider to the Company. Members who held Equity Share(s) of the Company as on Friday, 16th February, 2024 were entitled to vote through remote e-voting process in relation to the Resolutions

specified in the Postal Ballot Notice ("Eligible Members"). The dispatch of the Postal Ballot Notice by electronic mode was completed on 27th February 2024.

- 2. In accordance with the MCA Circulars, the physical copy of the Postal Ballot Notice along with Postal Ballot forms and pre-paid business envelope was not sent to the members in accordance with the provisions specified under the MCA Circulars. Accordingly, the communication of the assent or dissent of the members had taken place through the remote e-voting system only.
- 3. On the basis of Register of Members made available by the Depositories viz., National Securities Depository Limited (NSDL) and Central Depository Services (India) Limited (CDSL), as on Friday, 16th February, 2024 ("cut-off date"), the notice of the postal ballot dated Wednesday, 21st February, 2024 was dispatched to the shareholders by prescribed mode and the advertisement was published on Wednesday, 28th February, 2024, pursuant to Rule 22(3) of the Companies (Management and Administration) Rules, 2014 (as amended).
- The remote e-voting commenced on Wednesday, February 28, 2024 from 9.00 A.M. (IST) and ended on Thursday, March 28, 2024 till 5.00 P.M. (IST). The e-voting services were provided by Link Intime India Pvt. Ltd.
- 5. All the data of remote e-voting i.e., the results of e-voting along with the list of shareholders who voted "For" and "Against" the Resolutions were downloaded from the e-voting portal of Link Intime India Pvt. Ltd, by unblocking the remote e-voting event on Thursday, March 28, 2024 till 5.00 P.M. (IST). in the presence of two witnesses, viz., Mr. Abhishek A, currently residing at #43/1 Sri Nidhi apartment, 3rd main, 6th Cross, Binny layout, Attiguppe, Vijayanagar, Bangalore 560040 and Mr. Kiran S, currently residing at #26, 1st cross, 1st main, Javaregowdanagar, Rajarajeshwari Nagar, Bangalore 560098.
- 6. All votes cast through remote e-voting up to 5.00 P.M. (IST) on Thursday, March 28, 2024, the last date, and time fixed by the Company, were considered for scrutiny.
