Scrutinizer's Responsibility

My responsibility as a scrutinizer is restricted to making a Scrutinizer's report of the votes cast by the members in respect of the resolutions contained in the Postal Ballot Notice. My report is based on report generated by voting through electronic means provided by Central Depository Services (India) Limited (CDSL) the authorized agency engaged by the Company to provide voting by electronic means and verification of data provided by Cameo Corporate Services Ltd., Registrar and Transfer Agent of the Company.

I submit my report as under:

- 1. In terms of Section 108 and Section 110 of Companies Act, 2013 read with rules and SEBI Listing Regulations, 2015, the Company had made arrangement with Central Depository Services (India) Limited ("CDSL") for providing facility of voting through electronic means ("Remote e-voting") to its members.
- 2. In terms of applicable circulars physical ballots were not dispatched to shareholders, accordingly, the communication of the assent and dissent of the members had taken place through remote e-voting process only.
- 3. As per Rule 20(4) and 22 (3) Companies (Management & Administration) Rules, 2014 the Company published an advertisement on 19th December, 2023 about the dispatch of Postal Ballot Notice in "Financial Express" (English Newspaper) and "Pratah Kal" (Marathi Newspaper).
- 4. The members of the Company whose name were recorded in the Register of Members or in the Register of Beneficial owners maintained for it by the depositories (in case of share held in dematerialized from) as on the cut-off date i.e., <u>08th December</u>, <u>2023</u> were entitled to avail the Remote e-voting facility, in respect of resolution set out in the Postal Ballot Notice.
- 5. In terms of Postal Ballot notice the Remote E-voting commenced on <u>Sunday</u>, <u>17th December</u>, <u>2023</u> (09:00 A.M. IST) and ended on <u>Monday</u>, <u>15th January</u>, <u>2024</u> (05:00 P.M. IST).
- 6. All votes cast through e-voting during the above-mentioned period, were considered for scrutiny and at the end of Remote e-voting period, the remote e-voting facility was blocked by Central Depository Services (India) Limited (CDSL).
- 7. The votes casted through remote e-voting facility were thereafter unblocked in the presence of two witnesses who were not in the employment of the Company.

- 8. We, have scrutinized and reviewed the remote e-voting and votes tendered therein based on the data downloaded from the Central Depository Services (India) Limited ("CDSL") e-voting system. Based on such reports generated by CDSL and relied upon by me, data regarding the e-votes was scrutinized on test check basis.
