1. With reference to communication dated 23-01-2024 related to matter of non-compliance related to maintenance of Structured Digital Database (SDD).

The aforesaid communication with regard to non-compliance with maintaining Structured Digital Database (SDD) was placed before the Board of Directors at its meeting held on February 05, 2024. Board of Directors deliberated had noted the remark and has following views regarding the same as per our first clarification dated 28th November 2023 we had communicated that company is in compliance with regulation Structured Digital Database (SDD) Reg. 3(5) and Reg. 3(6) of SEBI (Prohibition of Insider Trading) Regulations, 2015. And due to some misinterpretation of provisions related to company listed on BSE SME the company had not uploaded SDD Compliance certificate Company is in compliance with mainting of SDD Software with effect from September 2023.

And before September 2023 owing to the fact that Corporation has its own system of safeguarding disclosure of information and whereby Directors, auditor, officer and other employees are prohibited to divulge any information relating to, or to the affairs of, its constituents except in circumstances in which it is, in accordance with the law or practice and usage.

The company had complied with the regulation with effect from September 2023 now the Company is in compliance with Structured Digital Database (SDD) Reg. 3(5) and Reg. 3(6) of SEBI (Prohibition of Insider Trading) Regulations, 2015.
