Dear Sir/s,

This has reference to SEBI Circular No. SEBI/HO/DDHS/CIR/P/2018/144 dated 26.11.2018 with respect to fund raising by issuance of debt securities by Large Entities.

In this connection, we wish to submit that though Jaypee Infratech Limited has an outstanding long term borrowing of over Rs. 100 crore as on 31st March, 2020, however the circular on fund raising by issuance of Debt Securities by ‘Large Entities’ **is not applicable to the Company** as it does not fulfill the criteria of credit rating of “AA and above” as per point 2.2.(iii) of the aforesaid circular. It may kindly be noted that at present the Credit Rating of the Company is “**CARE D**” (Single D) by CARE Ratings Limited.

Accordingly, the Company is not required to submit the Initial Disclosure under “Annexure A” as per aforesaid circular.
