I further report that the company had received from SEBI an order dated 11.03.2022 in compliance with directions of the Hon'ble Bombay high court vide order dated November 01,2021 in the matter of writ petition No.24095 for violation of SAST Regulations and action against Aruna Hotels Limited for violation of regulation 30(12) of LODR regulation for various matters for the year 2015/16.

During the year under review SEBI had communicated to the applicants vide letter dated May 23, 2023 about the settlement amount payable which amounted to Rs.23205000/-. Applicants had paid the amount and communicated the same to SEBI vide letter dated June 1, 2023.

Accordingly, SEBI had given the final settlement order on the same acknowledging the payment, vide Order dated June 07, 2023 and the same had been intimated to BSE by the company vide letter dated June 08, 2023.
