Based on our review conducted and procedures performed as stated in paragraph 3 above and based on the consideration of the management's certificates referred to in paragraph 6 below, nothing has come to our attention that causes us to believe that the accompanying Statement, prepared in accordance with the recognition and measurement principles laid down in the aforesaid Indian Accounting Standard and other accounting principles generally accepted in India, has not disclosed the information required to be disclosed in terms of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended, including the manner in which it is to be disclosed, or that it contains any material misstatement.
- 6. We draw attention that Consolidated Financial Statement wherein Gujarat Mineral Research & Industrial Consultancy Society (GMRICS) a Controlled trust of the company has not been considered in preparation of Consolidated Financial Statement, as GMRICS has not prepared its Annual Accounts due to Non-Financial Transactions since 2012-13. Our Conclusion is not modified in respect of this matter.



7. The consolidated unaudited financial results includes the interim financial results of a 100% controlled entity which have not been reviewed by their auditors, whose interim financial Information reflect total revenue of Rs. 44.81 lac and Rs. 134.44 lac, total net profit/(loss) after tax of Rs. (15.14) lac and Rs.(45.44) lac and total comprehensive income / (loss) of Rs. (15.14) lac and Rs. (45.44) lac for the quarter ended 31st December 2020 and for the period from 01 April 2020 to 31st December 2020 respectively. Further the consolidated unaudited financial results includes the Group's share of net profit/(loss) after tax of Rs. 121.40 lac and Rs. 97.42 lac and total comprehensive income / (loss) of Rs. 121.40 lac and Rs. 97.42 lac for the quarter ended December 31st 2020 and for the period from 1st April 2020 to 31st December 2020 respectively, as considered in the consolidated unaudited financial results, in respect of Three associates and Three joint ventures, based on their interim financial results which have not been reviewed by their auditors. According to the information and explanations given to us by the Management, these interim financial results are not material to the Group. Our conclusion on the Statement is not modified in respect of the above matter.
