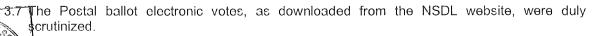


## REPORT OF SCRUTINIZER ON POSTAL BALLOT CARRIED OUT FOR MACROTECH DEVELOPERS LIMITED

To, The Chairman, **MACROTECH DEVELOPERS LIMITED** 412 Floor- 4, 17G Vardhaman Chamber Cawasji Patel Road, Horniman Circle, Fort Mumbai 400001

I, Shravan A. Gupta, Practicing Company Secretary, Proprietor of M/s. Shravan A. Gupta & Associates, have been appointed as scrutinizer by the Board of Directors of **MACROTECH DEVELOPERS LIMITED** ("the Company") for the purpose of scrutinizing the Postal Ballot Voting through remote e-voting process by shareholders and ascertaining the requisite majority on e-voting carried out as per the provision of Section 110 of the Companies Act, 2013 read with Rule 20 & 22 of companies (Management and Administration) Rules, 2014, on the 1 (One) Special resolution contained in the notice of Postal Ballot dated January 27, 2024.

- 1. The Management of the company is responsible for ensuring compliance with the requirements of the Companies Act, 2013 and rules relating to voting through electronic means.
- 2. My responsibility as a scrutinizer for the e-voting process is restricted to making a scrutinizer's report of the votes cast "in favor" or "against" the resolution(s) stated above, based on the reports generated from the evoting system provided by National Securities Depository Limited ('NSDL') at https://www.evoting.nsdl.com/, the authorized agency to provide e-voting facilities, engaged by the Company.
- 3. I hereby submit my report as under
  - 3.1 As per General Circular Nos. 14/2020 dated April 8, 2020, 17/2020 dated April 13, 2020, 22/2020 dated June 15, 2020, 33/2020 dated September 28, 2020, 39/2020 dated December 31, 2020, 10/2021 dated June 23, 2021, 20/2021 dated December 08, 2021, 3/2022 dated May 05, 2022, 11/2022 dated December 28, 2022 and 09/2023 dated September 25, 2023 (the "MCA Circulars"), the Company completed the despatch of Postal Ballot Notice (for the process of remote e-voting) on January 29, 2024, by email, only to members whose email IDs were registered with the Company & Link Intime India Private Limited ('Registrar and Share Transfer Agent / RTA') and whose name appeared on the register of members/list of beneficial owners as on the cut-off date i.e., January 19, 2024.
  - 3.2 The e-voting period opened at 9:00 AM (IST) on January 31, 2024 and closed at 5.00 pm (IST) on February 29, 2024.
  - 3.3 All the votes received up to 5.00. P.M. on February 29, 2024 being the last date and time fixed by the company for remote e-voting, were considered for my scrutiny. The e-voting was disabled immediately thereafter.
  - 3.4 A total no of 871 shareholders have cast their vote on the e-voting platform.
  - 3.5 The results of Postal Ballot through e-voting were unblocked by me by accessing the data downloaded by me from the website of <u>https://www.evoting.nsdl.com/</u>, in presence of two witness Mr. Sahil Gupta and Miss Manisha Sharma who are not the employees of the Company
  - 3.6 Since the voting on Postal Ballot process was conducted only through remote e-voting, reporting on number of envelopes containing postal ballot form received after due date and up to the date of this report or returned undelivered does not arise.





- 3.8 The particulars of postal ballot received from members in electronic voting report generated from <u>information works are all covers</u> have been entered in a separate register maintained for the purpose.
- 3.9 I have emailed all the registers and records relating to e-voting for the safe custody to the Company Secretary.
