Further SEBI vide its press release dated 27th March, 2019 clarified that the transfer deeds lodged prior to deadline and returned due to deficiency in the document may be re-lodged for transfer even after the deadline of 01st April, 2019 and cut-off date for such re-lodgement of transfer deed is 31st March, 2021 as fixed by SEBI vide Press Release No. 45/2020 dated 9th September, 2020.

At present, due to the continuing COVID 19 related pandemic, it is not possible for us to physically visit the office of C B Management Services Pvt. Ltd. (hereinafter referred to as the RTA), the Registrar and Share Transfer Agents of UNITED CREDIT LIMITED (the Company).
