Pursuant to the provision of Regulation 30 of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 and further in continuation of our corporate announcement dated 10<sup>th</sup> October, 2022, we wish to inform you that the Hon'ble Supreme Court of India ("the Court") has pronounced the judgement on 06<sup>th</sup> March 2024 and uploaded on 19<sup>th</sup> March 2024 in the matter of "DECCAN VALUE INVESTORS L.P. & ANR V/s DINKAR VENKATASUBRAMANIAN & ANR" and setting aside the impugned judgment dated 07<sup>th</sup> February, 2020 passed by the Hon'ble National Company Law Appellate Tribunal ("NCLAT"), upholding the order passed by Hon'ble National Company Law Tribunal ("NCLT"), dated 27<sup>th</sup> September 2019 and approved the resolution plan, submitted by the resolution applicants Deccan Value Investors L.P. and DVI PE (Mauritius) Ltd.

Additionally, the Hon'ble Supreme Court of India also directed the concerned parties to appear before the Hon'ble NCLT on 09<sup>th</sup> April, 2024 for further proceedings.
