Independent Auditor's certificate on book value of assets of Gujarat Fluorochemicals Limited ("the Company") contained in Columns A to J of "Statement of Security Cover and Statement of Compliance Status of Financial and Other Covenants in respect of non-convertible debentures issued under ISIN INE09N307018 by the Company as at and for the year ended 31<sup>st</sup> March 2024" ("the Statement")

- We, Patankar & Associates, Chartered Accountants, the independent auditors of Gujarat Fluorochemicals Limited ("the Company"), have been requested by the Management of the Company to certify book value of assets of the Company contained in Columns A to J of the Statement, and whether the Company has complied with financial and other covenants in respect of listed secured non-convertible debentures ("NCDs") issued and outstanding as at 31<sup>st</sup> March 2024.
- 2) The Statement is prepared by the Company from the audited books of account and other relevant records and documents maintained by the Company as at and for the year ended 31<sup>st</sup> March 2024 pursuant to requirements of Circular no. SEBI / HO / MIRSD / MIRSD \_ CRADT / CIR / P / 2022 / 67 dated May 19, 2022 issued by Securities and Exchange Board of India ("SEBI") in terms of regulation 54 read with regulation 56(1)(d) of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended ("the SEBI Regulations"), for the purpose of submission to debenture trustees and stock exchanges in respect of NCDs issued by the Company and outstanding as at 31<sup>st</sup> March 2024.

## Management's Responsibility

- 3) The accompanying Statement, including the preparation and maintenance of all accounting and other records supporting its contents, are solely the responsibility of the management of the Company. The Company's management is responsible for the designing, implementing and maintaining internal control relevant to the preparation and presentation of the Statement, and applying an appropriate basis of preparation; and making estimates that are reasonable in the circumstances.
- 4) The management of the Company is also responsible for ensuring that the Company complies with all the relevant requirements of the SEBI Regulations and for providing all relevant information to the debenture trustees and for complying with all the covenants as prescribed in the terms of Debenture Trust Deed.



## Auditor's Responsibility

- 5) Pursuant to the requirements of Circular no. SEBI / HO / MIRSD / MIRSD \_ CRADT / CIR / P / 2022 / 67 dated May 19, 2022 issued by SEBI, our responsibility in respect of this certificate is to provide a limited assurance on whether the book values of the assets of the Company contained in Columns A to J of the Statement have been accurately extracted and ascertained from the audited books of account of the Company and other relevant records and documents maintained by the Company, and whether the Company has complied with financial and other covenants in respect of NCDs.
- 6) A limited assurance engagement involves making inquiries, primarily of the Company's personnel responsible for financial and accounting matters, and applying analytical and other review procedures. The procedures performed vary in nature and timing from a reasonable assurance engagement. Consequently, the level of assurance obtained in a limited assurance engagement is substantially lower than the assurance that would have been obtained had a reasonable assurance engagement been performed.

Accordingly, we have performed the following procedures in relation to the statement:

- a) Obtained the Statement from the Management.
- b) Verified the details of security cover, financial covenants and other covenants criteria for the listed NCDs from the debenture trust deed.
- c) Traced the value of assets forming part of the security cover details from the audited books of account and other relevant records and documents maintained by the Company for the year ended 31<sup>st</sup> March 2024.
- Recomputed the security coverage ratio based on the information as obtained in the point (a) and (b) above.
- e) Verified that the computation of financial covenants as at 31<sup>th</sup> March 2024 is in accordance with the basis of computation given in the Debenture Trust Deed, and the amounts used in such computation have been accurately extracted from audited books of account of the Company as at and for the year ended 31<sup>st</sup> March 2024 and other relevant records and documents maintained by the Company, in the normal course of its business.
- f) Verified the arithmetical accuracy of the Statement.
- g) Based on the procedure performed in (e) and (f), evaluated whether the Company has complied with such financial covenants; and.
- h) Performed necessary inquiries with the management and obtained necessary representations.



- 7) We conducted our examination of the Statement in accordance with the Guidance Note on Reports or Certificates for Special Purposes issued by the Institute of Chartered Accountants of India. The Guidance Note requires that we comply with the ethical requirements of the Code of Ethics issued by the Institute of Chartered Accountants of India.


### Opinion
