# Genesys International Corporation awarded INR 46 crores for Land Titling Project by the Andhra Pradesh Government.

Mumbai, October 11, 2022: Genesys International Corporation, one of the leading homegrown players in the geospatial services sector, has won a INR 46 crore project for resurveying with modern technology using CORS Network, GNSS Receiver, and Aerial Systems from the Andhra Pradesh government. The resurveying is enabled by the sensors in the Genesys Constellation that provide the biggest swath in the world, which is generated by a single frame that captures more than 25000 pixels. Due to its capacity for acquiring highly accurate data sets at high speeds, it will be able to reduce long-standing problems with land titling and the ensuing legal issues with land records, which obstruct the acquisition of land for numerous infrastructure projects and present serious difficulties."

Genesys, which has partnered with companies like Google, ESRI and Bentley to launch services such as 'Street View' and '3D City Digital Twin Solution', is hopeful that this initiative will further gain momentum in other Indian states and usher in an era of modernization in the land recording.
