This is with respect to your email dated 12<sup>th</sup> April, 2024, in relation to an intimation made by the Company on 08<sup>th</sup> April, 2024 for receipt of a notice pertaining to payment of Goods and Services Tax ("**Intimation**"). Our response is set forth below:

We would like to submit that the order passed by the Assistant Commissioner State Tax, Office of DCCT/CTO/ACCT of Commercial Taxes, Patna Special Circle ("**Statutory Authority**") under the Goods and Services Tax Act, 2017 ("**Order**") was received by the Company on Saturday, 06<sup>th</sup> April, 2024.
