We are writing in response to the communication received from query.lodr@bseindia.com on January 17, 2024, regarding additional details required for corporate announcement filed under Regulation 30 of SEBI (LODR) Regulations, 2015. In the said communication, it was brought to our attention that our company had not submitted the additional details required under SEBI Circular SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated July 13, 2023, mentioning the order details for the order Received under Corporate Announcement filed under Regulation 30 of SEBI (LODR) Regulations, 2015 on January 16, 2024.

We appreciate your vigilance in monitoring compliance with regulatory requirements and would like to provide clarification regarding the situation. In our case, we would like to highlight those provisions of the circular dated July 13, 2023 stating the disclosure of additional details of the order received under Regulation 30 of SEBI (LODR) Regulations, 2015 for “Awarding, bagging/ receiving, amendment or termination of awarded/bagged orders/contracts, *not in the normal course of business*”, is not applicable to us as the order received by Company is under normal course of business. Yet, the Company make announcement of these receipts of Letter of Award, voluntarily. Therefore, we do not mention the additional details as required in the circular, in order to maintain confidentiality of business projects.

We understand the importance of compliance and, as a responsible listed company, have always strived to meet our regulatory obligations. We are at your disposal to provide any additional information or documents that may be required to address this matter.
